GENERAL

GENERAL ARRANGEMENTS

The Conference is meeting in the Austria Center Vienna (ACV), Bruno Kreisky Platz 1, 1220 Vienna, which is located next to the Vienna International Centre (VIC). The ACV telephone number is 212 44 00.

The starting time of all meetings will be announced in the Journal. Delegates are requested to be in their places by those times to allow meetings to start punctually. Evening meetings will be announced during the session if they become necessary.

Attached are seating plans for Conference Room A (plenary meetings) and Conference Room B (Committee of the Whole). The numbers in square brackets (e.g. [No. 7]) identifying locations throughout this document correspond to the ACV floor plans that are also attached for your convenience.

FORMALITIES ON ARRIVAL

Each participant will require a badge with a photograph for entry into the ACV during the session. SPECIAL EVENTS

'New Framework for the Utilization of Nuclear Energy in the 21st Century: Assurances of Supply and Non-Proliferation' A new framework to strengthen controls over access to sensitive nuclear technology — uranium enrichment and plutonium separation — will be the focus of a special event from 19 to 21 September 2006, attended by Ministers, other high-level dignitaries and experts.

Held over two and a half days, this event will outline a new framework to facilitate peaceful uses of nuclear energy, while limiting the further spread of nuclear weapon related technologies. High-level delegations from the Agency's 140 Member States are expected to attend.

The objective of this event is to stimulate discussion on the recent new approaches to the nuclear fuel cycle, with a view to developing the outlines of a 'new framework', as noted by the Director General, focusing in the first instance on 'assurances of supply and assurances of non-proliferation' and on identifying the next steps for the near- to mid-term. The programme will be distributed to all delegations.

MEPhI Men's Choir Russia has a long-standing choral tradition stemming from ancient orthodox hymns. Particularly celebrated and impressive are the male choirs, whose distinctive sound combines deep bass voices with clear tenors.

***‘50 Years —
Memorabilia’

In commemoration of the first fifty years of the IAEA, a ‘50 years — memorabilia exhibit’ is on display in the Rotunda of the ACV throughout the General Conference.

The exhibition features items from US President Eisenhower's ‘Atoms for Peace’ address to the General Assembly of the United Nations on 8 December 1953, as well as significant memorabilia from the early days of the IAEA. A photo gallery depicting significant events that occurred during the first half century of the IAEA is an integral part of the exhibition.

***Nobel Peace Prize
Exhibit ‘Make
Power — Not War’***

The 2005 Nobel Peace Prize was shared in two equal parts between the IAEA and its Director General Mohamed ElBaradei. It was awarded for their work to prevent nuclear energy from being used for military purposes and to ensure that it is used in the safest possible way for the benefit of humankind.

A photographic exhibit ‘Make Power — Not War’ featuring the 2005 Nobel Peace Prize Laureate — the IAEA and Dr Mohamed ElBaradei — is on display in the Rotunda of the ACV, throughout the week of the General Conference.

The exhibition depicts the many and varied facets of IAEA life, in photographs, text and cartoons: from the anti-nuclear protests sometimes staged outside the Agency’s Vienna Headquarters, to the work of its safeguards inspectors, its role in nuclear safety, and its efforts to promote the peaceful uses of nuclear technology.

The IAEA would like to acknowledge with appreciation the loan of the exhibit from the Nobel Peace Center. It was produced in cooperation with Dagbladet Magasinet and the Norwegian Institute of International Affairs. It is the Center’s first major exhibition on a Laureate since the museum opened in Oslo in 2005.

Four videos provided by the Nobel Peace Center will also be shown as part of the exhibit:

‘A Race Against Time’ is a half hour documentary that focuses on Dr ElBaradei and the IAEA's work. It was produced by the Norwegian Broadcasting Corporation, NRK, for use by television networks worldwide.

‘The Nobel Year in Norway’ is a 10 minute film depicting how the Nobel Peace Prize winner is chosen, the selection committee, the announcement, and the different festivities and ceremony that occur during the week that the prize is awarded in Oslo, Norway.

‘The Nobel Prize’ is a short film that goes behind the Prize, to examine what it is, why it was started, and why it is so prestigious. The short film discusses the role of the Nobel Committee and touches on the Prize’s controversial winners.

‘The Nobel Winners’ highlights some 20 different Nobel Peace Prize winners, since the prestigious prize was started in 1901. The Laureates are profiled in short 3–5 minute clips that often integrate historical footage.

There have been more than 115 000 visitors to the Nobel Peace Center since it opened in June 2005.

The IAEA is featuring a special exhibition about its multi-faceted work for protecting the air, earth and oceans through applications of nuclear science and technology, and showcases the many ways in which the IAEA supports activities for sustainable environmental management around the world. The Director General Mohamed ElBaradei and His Serene Highness Prince Albert II of Monaco are officially opening the event:

**Marie Curie-
Skłodowska
Exhibit**

On the occasion of the Agency's 50th General Conference, Poland and France are donating to the IAEA a sculpture, dated 1930, by Polish artist Ludwika Nitschowa, representing Marie Curie-Skłodowska. Both nations wish to associate the IAEA and its Director General, honoured by the Nobel Prize for their contributions to progress and peace, with Marie Curie-Skłodowska in this homage.

The donation will take place during a ceremony on Monday, 18 September 2006, at 6.15 p.m., the first day of the IAEA's General Conference.

Marie Curie-Skłodowska (1867–1934) was an eminent scientist born in Warsaw, Poland. In 1903 she became the first woman in France to complete her doctorate, and the same year, together with her husband Pierre Curie and Henri Becquerel, she was awarded the Nobel Prize in Physics, “in recognition of the extraordinary services they have rendered by their joint researches on the radiation phenomena”.

Later, Marie Curie-Skłodowska demonstrated that radioactivity is an atomic property and in 1911 was awarded a second Nobel Prize, this time in Chemistry, for the discovery of polonium (named this way to pay tribute to her native land) and radium, and the study of its properties.

At the cost of her life, Marie Curie-Skłodowska launched one of the greatest adventures of modern times and offered an exceptional contribution to the progress of humanity. The radioactivity science she founded, together with her husband Pierre Curie, is the basis of numerous applications in many fields of medicine and energy. Her discoveries have benefited countless numbers of people whose cancers could be treated thanks to radiotherapy. At the end of World War I during which her admirable action in military hospitals allowed many lives to be saved, this woman of science and courage founded the Radium Institute in Paris. Later she also supported the founding of the Radium Institute in Warsaw. She was the inspiration and mentor of many researchers trained in these institutes.
