## **SUMMARY OF MEETINGS**

**PLENARY  
1<sup>ST</sup> MEETING**

The Conference, under item 1 of the provisional agenda, “Election of officers and appointment of the General Committee”, elected by acclamation His Excellency Abdul Samad Minty, the Governor from South Africa on the Agency’s Board of Governors, as President of the General Conference at its fiftieth regular session.

In line with a proposal by the President, the Conference elected the delegates of Bolivia, Belgium, Canada, Egypt, the Islamic Republic of Iran, the Republic of Korea and the Russian Federation as Vice-Presidents of the Conference. Also, in line with a proposal by the President, the Conference elected Mr Peter Shannon as Chairperson of the Committee of the Whole, and the delegates of Cyprus, France, Poland, the Syrian Arab Republic, the United States of America and the Bolivarian Republic of Venezuela as additional members of the General Committee.

Under item 2, “Applications for membership of the Agency”, the Conference approved by acclamation the applications for membership of the Agency submitted by the Republic of Malawi, the Republic of Montenegro, the Republic of Mozambique and the Republic of Palau.

Under item 3 of the provisional agenda, His Excellency Heinz Fischer, the Federal President of the Republic of Austria, made a statement to the General Conference.

Under item 4 of the provisional agenda, the Secretary-General of the United Nations, Mr Kofi Annan, delivered a video message.

Under item 5 of the provisional agenda, Mr Mohamed ElBaradei, Director General of the Agency, reviewed the rising expectations for expansion of nuclear power – emphasizing the need for energy for development – and gave examples of nuclear applications that were providing humanitarian benefit. He discussed progress and new initiatives in nuclear safety, nuclear security, and nuclear verification; reviewed the strides forward that various Member States had made under the TC programme; and highlighted a number of management issues. He closed by outlining the need for a new multilateral framework for the nuclear fuel cycle.

Under item 7 of the provisional agenda, the President made a statement regarding the early pledging and payment of contributions to the Technical Cooperation Fund for 2007, which greatly helps the Secretariat in planning the Agency’s technical cooperation programme.

The Conference took up item 8 of the provisional agenda, “General debate and Annual Report for 2005” and statements were made by the delegates of Mexico, the United States of America, the European Union (Finland), the Islamic Republic of Iran, Japan and the Republic of Korea.

**Plenary  
2<sup>nd</sup> meeting** The Conference resumed consideration of item 8 of the agenda, “General debate and Annual Report for 2005”. Statements were made by Saudi Arabia, Austria, Russian Federation, China, Croatia, Holy See, Pakistan, South Africa, Argentina, Sudan, Namibia and Tunisia. A statement was made by the Secretary General of the Agency for the Prohibition of Nuclear Weapons in Latin America and the Caribbean (OPANAL).

### **GENERAL ARRANGEMENTS**

To make more efficient use of the general debate, and in line with recommendations on streamlining the work of the General Conference, delegates are urged to keep the duration of their oral presentations down to **15 minutes**, by focusing on the main points that they wish to make. Copies of the full texts (in the original language) will be made available to other delegates during the session, if delegates so request. Statements during committee sessions should be kept to a maximum of **5 minutes**.

To facilitate interpretation, the texts of statements to be delivered should be handed to the Conference Officer in advance. In addition, to facilitate the posting of statements on the Agency’s website, copies of statements should be provided in electronic form as early as possible to the IAEA Division of Public Information. To facilitate the preparation of the records of the proceedings, it would be appreciated if delegates intending to provide the Secretariat with texts of statements would have them typed double-spaced (like this paragraph).

## **SPECIAL EVENTS**

**'New Framework for the Utilization of Nuclear Energy in the 21st Century: Assurances of Supply and Non-Proliferation'**

A new framework to strengthen controls over access to sensitive nuclear technology — uranium enrichment and plutonium separation — will be the focus of a special event from 19 to 21 September 2006, attended by Ministers, other high-level dignitaries and experts.

Held over two and a half days, this event will outline a new framework to facilitate peaceful uses of nuclear energy, while limiting the further spread of nuclear weapon related technologies. High-level delegations from the Agency's 140 Member States are expected to attend.

The objective of this event is to stimulate discussion on the recent new approaches to the nuclear fuel cycle, with a view to developing the outlines of a 'new framework', as noted by the Director General, focusing in the first instance on 'assurances of supply and assurances of non-proliferation' and on identifying the next steps for the near- to mid-term. The programme will be distributed to all delegations.

***‘50 Years —

In commemoration of the first fifty years of the IAEA, a ‘50 years — memorabilia exhibit’ is on display in the Rotunda of the ACV throughout the General Conference.

The exhibition features items from US President Eisenhower's ‘Atoms for Peace’ address to the General Assembly of the United Nations on 8 December 1953, as well as significant memorabilia from the early days of the IAEA. A photo gallery depicting significant events that occurred during the first half century of the IAEA is an integral part of the exhibition.

***Nobel Peace Prize  
Exhibit ‘Make  
Power — Not War’***

The 2005 Nobel Peace Prize was shared in two equal parts between the IAEA and its Director General Mohamed ElBaradei. It was awarded for their work to prevent nuclear energy from being used for military purposes and to ensure that it is used in the safest possible way for the benefit of humankind.

A photographic exhibit ‘Make Power — Not War’ featuring the 2005 Nobel Peace Prize Laureate — the IAEA and Dr Mohamed ElBaradei — is on display in the Rotunda of the ACV, throughout the week of the General Conference.

The exhibition depicts the many and varied facets of IAEA life, in photographs, text and cartoons: from the anti-nuclear protests sometimes staged outside the Agency’s Vienna Headquarters, to the work of its safeguards inspectors, its role in nuclear safety, and its efforts to promote the peaceful uses of nuclear technology.

The IAEA would like to acknowledge with appreciation the loan of the exhibit from the Nobel Peace Center. It was produced in cooperation with Dagbladet Magasinet and the Norwegian Institute of International Affairs. It is the Center’s first major exhibition on a Laureate since the museum opened in Oslo in 2005.

**Four videos provided by the Nobel Peace Center will also be shown as part of the exhibit. They will be shown until Thursday at 1.00 p.m. in Hall E on the entrance level of the ACV.**

‘A Race Against Time’ is a half hour documentary that focuses on Dr ElBaradei and the IAEA's work. It was produced by the Norwegian Broadcasting Corporation, NRK, for use by television networks worldwide. ‘The Nobel Year in Norway’ is a 10 minute film depicting how the Nobel Peace Prize winner is chosen, the selection committee, the announcement, and the different festivities and ceremony that occur during the week that the prize is awarded in Oslo, Norway.

‘The Nobel Prize’ is a short film that goes behind the Prize, to examine what it is, why it was started, and why it is so prestigious. The short film discusses the role of the Nobel Committee and touches on the Prize’s controversial winners.

‘The Nobel Winners’ highlights some 20 different Nobel Peace Prize winners, since the prestigious prize was started in 1901. The Laureates are profiled in short 3–5 minute clips that often integrate historical footage.

There have been more than 115 000 visitors to the Nobel Peace Center since it opened in June 2005.

**Marie Curie-  
Sklodowska Exhibit**

On the occasion of the Agency’s 50<sup>th</sup> General Conference, Poland and France are donating to the IAEA a sculpture, dated 1930, by Polish artist Ludwika Nitschowa, representing Marie Curie-Sklodowska. Both nations wish to associate the IAEA and its Director General, honoured by the Nobel Prize for their contributions to progress and peace, with Marie Curie-Sklodowska in this homage.

Marie Curie-Sklodowska (1867–1934) was an eminent scientist born in Warsaw, Poland. In 1903 she became the first woman in France to complete her doctorate, and the same year, together with her husband Pierre Curie and Henri Becquerel, she was awarded the Nobel Prize in Physics, “in recognition of the extraordinary services they have rendered by their joint researches on the radiation phenomena”.

Later, Marie Curie-Sklodowska demonstrated that radioactivity is an atomic property and in 1911 was awarded a second Nobel Prize, this time in Chemistry, for the discovery of polonium (named this way to pay tribute to her native land) and radium, and the study of its properties.

At the cost of her life, Marie Curie-Sklodowska launched one of the greatest adventures of modern times and offered an exceptional contribution to the progress of humanity. The radioactivity science she founded, together with her husband Pierre Curie, is the basis of numerous applications in many fields of medicine and energy. Her discoveries have benefited countless numbers of people whose cancers could be treated thanks to radiotherapy. At the end of World War I during which her admirable action in military hospitals allowed many lives to be saved, this woman of science and courage founded the Radium Institute in Paris. Later she also supported the founding of the Radium Institute in Warsaw. She was the inspiration and mentor of many researchers trained in these institutes.

This year, the World Nuclear University (WNU) stand, located in Area C on the 2nd floor of the ACV, is exhibiting a new publication: *The World Nuclear University Primer: Nuclear Energy in the 21st Century*. The primer is an authoritative resource for educators, students and interested lay-people needing to further their understanding of nuclear science and technology. This edition is co-published with Elsevier and features a Foreword by co-founder of Greenpeace, Dr Patrick Moore.

The school, which is currently running its first course for in situ leach mining operators, aims to support environmentally-friendly uranium production around the world.

### ***Visit to the IAEA Laboratories in Seibersdorf***

Tomorrow, 20 September 2006, delegates (or persons designated by them) will have an opportunity to visit the Agency's Laboratories in Seibersdorf.

The Laboratories, situated about 35 km south-east of Vienna, contribute to the Agency's programmes through experimental activities relating to nuclear verification, applications of radiation and isotopes in food and agriculture, the sterile insect technique, nuclear instrumentation, radiation dosimetry, and nuclear techniques for monitoring radioactive and other contaminants in the environment. The laboratories also serve as a training centre for scientists from developing countries. In addition, quality control services for analytical and radiometric measurements and radiation applications are provided at Seibersdorf for the benefit of Member States' laboratories and institutes.

Registration for the visit should be made at the Information Desk on the 2<sup>nd</sup> floor at the ACV. The bus seats a maximum of 58 persons and **departs from the VIC at 9.00 a.m.**
