SUMMARY OF MEETINGS

PLENARY
7th meeting

The Conference resumed consideration of item 8 of the agenda, “General debate and Annual Report for 2005”. Statements were made by Azerbaijan, Malaysia, United Republic of Tanzania, Vietnam, Colombia, Spain, Myanmar, Netherlands, Belgium, Peru, Greece and Niger.

With regard to the restoration of voting rights, the Conference agreed that the voting rights of Georgia and the Republic of Moldova should not be restored.

Under item 24 of the agenda, “Examination of delegates’ credentials” on which the General Committee presented the report contained in document GC(50)/27, the Conference adopted the draft resolution contained in paragraph 7 of that report, with the reservations and positions expressed therein.

Under item 9 of the agenda, “Election of Members to the Board of Governors”, the following Member States were elected to serve on the Board of Governors during the period 2006–2008: Austria, Bolivia, Brazil, Chile, Croatia, Ethiopia, Finland, Morocco, Nigeria, Pakistan and Thailand.

5th meeting

The Committee took up agenda item 15, “Nuclear security – measures to protect against nuclear terrorism” (draft resolution GC(50)/COM.5/L.10, “Progress on measures to protect against nuclear and radiological terrorism”) and agreed to recommend the adoption of the draft resolution in document GC(50)/L.3.

The Committee resumed its consideration of agenda item 17, “Strengthening the Agency’s activities related to nuclear science, technology and applications”. It discussed the draft resolution in document GC(50)/COM.5/L.7/Rev.1 and agreed to recommend to the General Conference the adoption of part 3 (Development of the Sterile Insect Technique for the Control or Eradication of Malaria-Transmitting Mosquitoes) and part 4 (Support to the African Union’s Pan African Tsetse and Trypanosomosis Eradication Campaign (AU-PATTEC)). The Committee agreed that a working group, under the chairmanship of Mr Beven of Australia, would consider the merging into one resolution of draft resolutions GC(50)/COM.5/L.7/Rev.1 and GC(50)/COM.5/L.3/Rev.1.

PLENARY
8th meeting

The Conference concluded item 8 of the agenda, “General debate and Annual Report for 2005”. Statements were made by Ecuador, Haiti, Singapore, Ireland, Uganda, Jordan and Palestine.

6th meeting

The Committee agreed to recommend to the General Conference:

- under agenda item 16, "Strengthening of the Agency's technical cooperation activities", the adoption of draft resolution GC(50)/L.6;
- under agenda item 22, "Amendment to Article VI of the Statute", the adoption of draft decision GC(50)/L.8;
- under agenda item 23, "Election to the Agency's Staff Pension Committee", the election of Ms Noor Hasnah Mohamed Khairullah of Malaysia and Ms Olivia Preston of the United Kingdom as alternate members to the Agency's Staff Pension Committee.

The Committee continued its consideration of agenda item 17, "Strengthening the Agency's activities related to nuclear science, technology and applications".

Under agenda item 18, "Strengthening the effectiveness and improving the efficiency of the safeguards system and application of the Model Additional Protocol", the Committee agreed on draft resolution GC(50)/COM.5/L.1/Rev.2 with the exception of one operative paragraph, regarding which some delegations expressed concerns.

***‘50 Years —
Memorabilia’
Exhibit***

In commemoration of the first fifty years of the IAEA, a ‘50 years — memorabilia exhibit’ is on display in the Rotunda of the ACV throughout the General Conference.

The exhibition features items from US President Eisenhower's ‘Atoms for Peace’ address to the General Assembly of the United Nations on 8 December 1953, as well as significant memorabilia from the early days of the IAEA. A photo gallery depicting significant events that occurred during the first half century of the IAEA is an integral part of the exhibition.

***Nobel Peace Prize
Exhibit ‘Make
Power — Not War’***

The 2005 Nobel Peace Prize was shared in two equal parts between the IAEA and its Director General Mohamed ElBaradei. It was awarded for their work to prevent nuclear energy from being used for military purposes and to ensure that it is used in the safest possible way for the benefit of humankind.

A photographic exhibit ‘Make Power — Not War’ featuring the 2005 Nobel Peace Prize Laureate — the IAEA and Dr Mohamed ElBaradei — is on display in the Rotunda of the ACV, throughout the week of the General Conference.

The exhibition depicts the many and varied facets of IAEA life, in photographs, text and cartoons: from the anti-nuclear protests sometimes staged outside the Agency’s Vienna Headquarters, to the work of its safeguards inspectors, its role in nuclear safety, and its efforts to promote the peaceful uses of nuclear technology.

The IAEA would like to acknowledge with appreciation the loan of the exhibit from the Nobel Peace Center. It was produced in cooperation with Dagbladet Magasinet and the Norwegian Institute of International Affairs. It is the Center’s first major exhibition on a Laureate since the museum opened in Oslo in 2005.

‘A Race Against Time’ is a half hour documentary that focuses on Dr ElBaradei and the IAEA's work. It was produced by the Norwegian Broadcasting Corporation, NRK, for use by television networks worldwide. ‘The Nobel Year in Norway’ is a 10 minute film depicting how the Nobel Peace Prize winner is chosen, the selection committee, the announcement, and the different festivities and ceremony that occur during the week that the prize is awarded in Oslo, Norway.

‘The Nobel Prize’ is a short film that goes behind the Prize, to examine what it is, why it was started, and why it is so prestigious. The short film discusses the role of the Nobel Committee and touches on the Prize’s controversial winners.

‘The Nobel Winners’ highlights some 20 different Nobel Peace Prize winners, since the prestigious prize was started in 1901. The Laureates are profiled in short 3–5 minute clips that often integrate historical footage.

There have been more than 115 000 visitors to the Nobel Peace Center since it opened in June 2005.

The IAEA is featuring a special exhibition about its multi-faceted work for protecting the air, earth and oceans through applications of nuclear science and technology, and showcases the many ways in which the IAEA supports activities for sustainable environmental management around the world.

**Marie Curie-
Sklodowska Exhibit**

On the occasion of the Agency’s 50th General Conference, Poland and France are donating to the IAEA a sculpture, dated 1930, by Polish artist Ludwika Nitschowa, representing Marie Curie-Sklodowska. Both nations wish to associate the IAEA and its Director General, honoured by the Nobel Prize for their contributions to progress and peace, with Marie Curie-Sklodowska in this homage.

Marie Curie-Sklodowska (1867–1934) was an eminent scientist born in Warsaw, Poland. In 1903 she became the first woman in France to complete her doctorate, and the same year, together with her husband Pierre Curie and Henri Becquerel, she was awarded the Nobel Prize in Physics, “in recognition of the extraordinary services they have rendered by their joint researches on the radiation phenomena”.

Later, Marie Curie-Sklodowska demonstrated that radioactivity is an atomic property and in 1911 was awarded a second Nobel Prize, this time in Chemistry, for the discovery of polonium (named this way to pay tribute to her native land) and radium, and the study of its properties.

At the cost of her life, Marie Curie-Sklodowska launched one of the greatest adventures of modern times and offered an exceptional contribution to the progress of humanity. The radioactivity science she founded, together with her husband Pierre Curie, is the basis of numerous applications in many fields of medicine and energy. Her discoveries have benefited countless numbers of people whose cancers could be treated thanks to radiotherapy. At the end of World War I during which her admirable action in military hospitals allowed many lives to be saved, this woman of science and courage founded the Radium Institute in Paris. Later she also supported the founding of the Radium Institute in Warsaw. She was the inspiration and mentor of many researchers trained in these institutes.

This year, the World Nuclear University (WNU) stand, located in Area C on the 2nd floor of the ACV, is exhibiting a new publication: *The World Nuclear University Primer: Nuclear Energy in the 21st Century*. The primer is an authoritative resource for educators, students and interested lay-people needing to further their understanding of nuclear science and technology. This edition is co-published with Elsevier and features a Foreword by co-founder of Greenpeace, Dr Patrick Moore.

Also featured on the stand is information about the newly-launched WNU School of Uranium Production located in the Czech Republic. The school, which is currently running its first course for in situ leach mining operators, aims to support environmentally-friendly uranium production around the world.

The emergency staircases in the ACV cannot be used for going from one floor to another. Although they can be entered on any floor, the only exits are at the -3 (i.e. lowest) level. They should therefore be used only in a real emergency. In the event of an emergency evacuation, please follow the instructions of the United Nations security personnel on duty.

The ACV meets all general safety and fire safety standards, thus ensuring the safe evacuation of the entire complex. All emergency exits and escape routes meet the highest safety standards. Emergency telephones may be found in-between the passenger elevators on all floors. Fire extinguishers and push-button alarms are located close to every staircase and inside the meeting rooms. The necessity for an evacuation of parts of the ACV or the entire complex will be communicated by the UN Security and Safety Services (UNSSS) personnel or by means of the public address system. Please follow the directions of the UNSSS personnel and evacuate the area via the communicated emergency escape route. Escape routes are marked according to EC standards (i.e. with arrows and lamps). All escape routes lead to the ground level of the ACV. Under no circumstances should elevators, escalators and/or stairs other than emergency staircases be used for evacuation purposes. Evacuees must remain in the close vicinity of the emergency escape route used, in order to receive further instructions from the UNSSS personnel.
