

NON - EXCLUSIVE LICENSE AGREEMENT
FOR THE USE OF THE DESALINATION ECONOMIC EVALUATION PROGRAM
(DEEP)

This Agreement is made between the International Atomic Energy Agency (hereinafter referred to as the "Licensor") whose address is Wagramerstraße 5, P.O. Box 100, A-1400 Vienna, Austria, and the Licensee requesting the DEEP software,

WHEREAS the Licensor is the sole owner of the Desalination Economic Evaluation Program (hereinafter referred to as "DEEP") software used as a tool for the comparative economic assessment of nuclear and fossil seawater desalination plants;

WHEREAS the Licensee desires to obtain a licence from the Licensor for the use of DEEP;

NOW, THEREFORE, the Licensor and the Licensee hereby agree as follows:

Article 1

License

1. The Licensor hereby grants and the Licensee hereby accepts, upon the terms and subject to the conditions contained herein, a non-exclusive license to use DEEP as a tool for the comparative economic assessment of nuclear and fossil seawater desalination plants. This non-exclusive license covers DEEP and any modifications which may be made thereto under the terms of Paragraph 2 of this Article.

2. For the purposes of this License "use" shall mean and include utilization of DEEP by copying or transmitting the same into a compatible computer system for the processing of the instructions or statements contained in DEEP. "Use" shall also mean to create new modules, or to improve or modify existing cases or modules contained in the software.

3. The Licensee may copy DEEP for back-up provided that no more than two (2) copies will be in existence at anyone time without prior written consent from the Licensor.

Article 2

License fee and other charges

1. This license is granted free of charge.
2. The Licensee agrees to reimburse any costs, including but not limited to, computer and/or delivery charges incurred by the Licensor in providing DEEP to the Licensee. Before incurring such costs the Licensor shall advise the Licensee and obtain the Licensee's prior written consent.

Article 3

Licensee undertakings

1. The Licensee expressly undertakes:
 - (a) to include the copyright notice of the Licensor on all and any copies, whether in whole or in part, in any form, including partial copies or modifications, of DEEP;
 - (b) to report and submit to the Licensor all papers and studies created by the Licensee involving the use of DEEP;
 - (c) to include the copyright notice of the Licensor with respect to DEEP on all and any papers or studies created by the Licensee involving the use of DEEP;
 - (d) to report and submit to the Licensor all modules newly created by the Licensee, as well as all improvements or modifications made by the Licensee to existing cases or modules contained in the software as specified in Paragraph 2 of Article 1 of this License Agreement;
 - (e) to assist, upon request of the Licensor, in the validation by the Licensor of such newly created modified cases or modules submitted by the Licensee as specified in Paragraph 1(d) of this Article;
 - (t) to replace the current version of DEEP with any upgraded version forthwith upon receipt;
 - (g) not to copy (other than for normal operation and as specified in Paragraph 3 of Article 1 of this License Agreement) or reproduce DEEP, nor to communicate the same to any third party without the Licensor's prior written consent;
 - (h) not to provide or otherwise make available DEEP in whole or in part (including but not limited to program listings, object and source program listings, object code and source code), in any form to any person without the prior written consent from the Licensor;

- (i) not to use DEEP for any commercial purpose.
2. The Licensee expressly acknowledges that the Licensor may, at its option, include modules newly created by the Licensee, as well as all improvements or modifications made by the Licensee to existing cases or modules, in future versions of DEEP; the software will in such cases be distributed by the Licensor under its name, and all intellectual property rights in relation thereto shall vest in the Licensor and be governed by the provisions of Article 5 of this License Agreement.
3. The Licensee expressly acknowledges that DEEP is to be used only as a tool for the comparative economic assessment of nuclear and fossil seawater desalination plants and only in the following manner:
 - (a) for calculation of the levelized cost of electricity and desalinated water as a function of quantity, site specific parameters, energy source and desalination technology;
 - (b) for side-by-side comparison of a large number of design alternatives on a consistent basis with common assumptions;
 - (c) for identification of the lowest cost options for providing specified quantities of desalinated water and/or power at a given location
4. The Licensee expressly acknowledges that DEEP shall not be used for the design of an individual seawater desalination plant.

Article 4 Liability

1. The Licensor shall not be liable to the Licensee for any loss or damage whatsoever or howsoever caused arising directly or indirectly in connection with this License Agreement, DEEP, its use or otherwise.
2. Notwithstanding the generality of Paragraph 1 of this Article, the Licensor expressly excludes liability for consequential loss or damage which may arise in respect of DEEP, its use or for loss of profit, business, revenue, goodwill or anticipated savings.

Article 5 Intellectual property rights

The Licensee acknowledges that any and all of the trademarks, trade names, copyrights, patents and other intellectual property rights used or embodied in or in connection with DEEP shall be and remain the sole property of the Licensor. The Licensee shall not during or at any time after the expiry or termination of this license in any way question or dispute such rights.

Article 6
Privileges and Immunities

Nothing in this Agreement shall be construed as a waiver of the privileges and immunities accorded to the Licensor by its Member States.

Article 7
Termination

1. Either Party may terminate this Agreement by sixty (60) days written notice to the other.
2. In addition, the Licensor may give thirty (30) days notice in writing to the Licensee to terminate this License Agreement if the Licensee is in breach of any term or provision of this license.
3. Within fourteen (14) days after the date of termination or discontinuance of this License Agreement for whatever reason, the Licensee shall return or destroy (as the Licensor shall instruct) DEEP and all copies, in whole and in part, in any form including partial copies of modifications of DEEP received from the Licensor or made in connection with this License and all documentation relating thereto and to furnish the Licensor with a certificate, certifying that the same has been done, unless the Licensee has obtained the Licensor's prior written authorization to retain one copy for archive purposes only.

Article 8
Amendments

This License Agreement shall not be subject to change, modification, or waiver of any of its provisions, in whole or in part, except by written instrument signed by the Licensor and the Licensee.

Article 9
Commencement and Duration

This Agreement shall enter into force on the date of the last signature by the Parties or their authorised representatives. It shall remain in force unless terminated in accordance with Article 7.
