Excellency,

On 11 January 2012 Mostafa Ahmadi Roshan, an Iranian nuclear scientist was targeted and immediately killed by a terrorist attack. The world, therefore, once again witnessed the ugly phenomenon of terrorism and the assassination of scientists and academicians in obvious violations of all humanitarian principles, the spirit of the UN Charter, the Statute of IAEA and international law. It is of utmost importance that urgent necessary measures should be taken in order to prevent the recurrence of such an incident in any part of the world particularly in developing countries whose scientists are considered the main foundation and valuable resources for sustainable development.

I hereby request you, in your capacity as the Chairman of the IAEA Board of Governors, while denouncing such a violent and heinous crime, to bring this matter to the due attention of the Members of the Board of Governors and to reflect it to the next Board of Governors so that concrete measures can be adopted accordingly by the IAEA Member States to impede this hideous phenomenon, i.e., terrorist attacks against scientists and academicians, specifically nuclear scientists. I am sure the international community is looking forward to seeing the IAEA Board of Governors' concrete measures in this respect.
