Introduction

The following pages contain financial and statistical data supplementing the Technical Cooperation Report for 2004. Again this year, the information is grouped under three headings as listed below, which allows the reader to make a comprehensive review of all information related to one subject. However, in a continuing effort to provide concise and transparent information, changes have been made in some of the tables from the presentation in 2003.

The countries are grouped by region in most of the tables. Annex 1 provides an alphabetical listing by region of all countries/territories that are mentioned in this report.

Unless otherwise specified, all amounts are expressed in United States dollars. As most figures are rounded to thousands of US dollars, the amounts in tables may not add up exactly to the totals shown due to rounding.

A. Resources and Contributions

The financial tables and graphs in this section show the resources received from various sources for technical cooperation activities.

B. Disbursement and Implementation Summaries

The financial tables and graphs in this section show actual disbursements (monetary outlays and in-kind support provided) and implementation against the adjusted programme for the year 2004 and, in some tables, for previous years as well.

C. Non-financial Indicators

The tables and graphs in this section provide figures on the actual physical outputs delivered through the technical cooperation programme, rather than the cost of the outputs. In some cases, figures on financial outputs are provided to complement that information.

The information contained in this Supplement is available in electronic format upon request. It is also available on GovAtom (restricted access). The Secretariat welcomes comments and suggestions for future improvements.

A. Resources and Contributions

Table A.1 Available resources: 1995–2004

This table shows resources by source of funding, based on the year in which the funds became available. The ‘other income’ of the Technical Cooperation Fund (TCF) includes assessed programme costs (APCs) received, interest income, and gains/losses on exchange. Other resources (extrabudgetary funds from Member States, United Nations Development Programme (UNDP), and in-kind) are shown separately.

Table A.2 Technical Cooperation Fund: 1995–2004

The ten-year development of the target for contributions to the TCF, the amounts pledged, and the payments against these pledges are shown. The payments as a percentage of the target gives the rate of attainment. In this table, contributions are shown not by the year in which they became available but by the programme year for which they were pledged and paid. Therefore, new pledges or withdrawals against prior year targets, as well as payments, are recorded against that year, and the percentages for earlier years may change.

Table A.3 Member States’ contributions pledged and paid to the Technical Cooperation Fund: 2004

This table reports on pledges and payments to the 2004 TCF target, set at \$74 750 000. The table is sorted according to the percentage of the target pledged. Of the 137 Member States, 74 pledged their full target (or more), 17 made partial pledges, and 46 made no pledge in 2004.

Table A.4 Assessed programme costs and national participation costs

This year the table is divided into two parts. Part A reports on arrears of assessed programme costs as of 31 December 2004. Part B shows the amounts invoiced in 2004 under the new national participation cost mechanism, together with amounts that had been received as of 31 December 2004.

Table A.5 Status of extrabudgetary funds: 2004

This table shows the status of extrabudgetary funds from each donor. Included in this table under Part B are funds from countries for their own projects, designated ‘government cost-sharing’. A total of 56 countries and three organizations are represented. Also included is the Nuclear Security Fund. Amounts shown here refer only to funds made available to the Department of Technical Cooperation in accordance with Board directives to make use of the competencies of the Department in implementing the Nuclear Security Action Plan. The ‘Funds available 1 January 2004’ column of the table represents the total of the unliquidated obligations and the unobligated balance carried forward from the end of 2003.

Table A.6 In-kind support: 2004

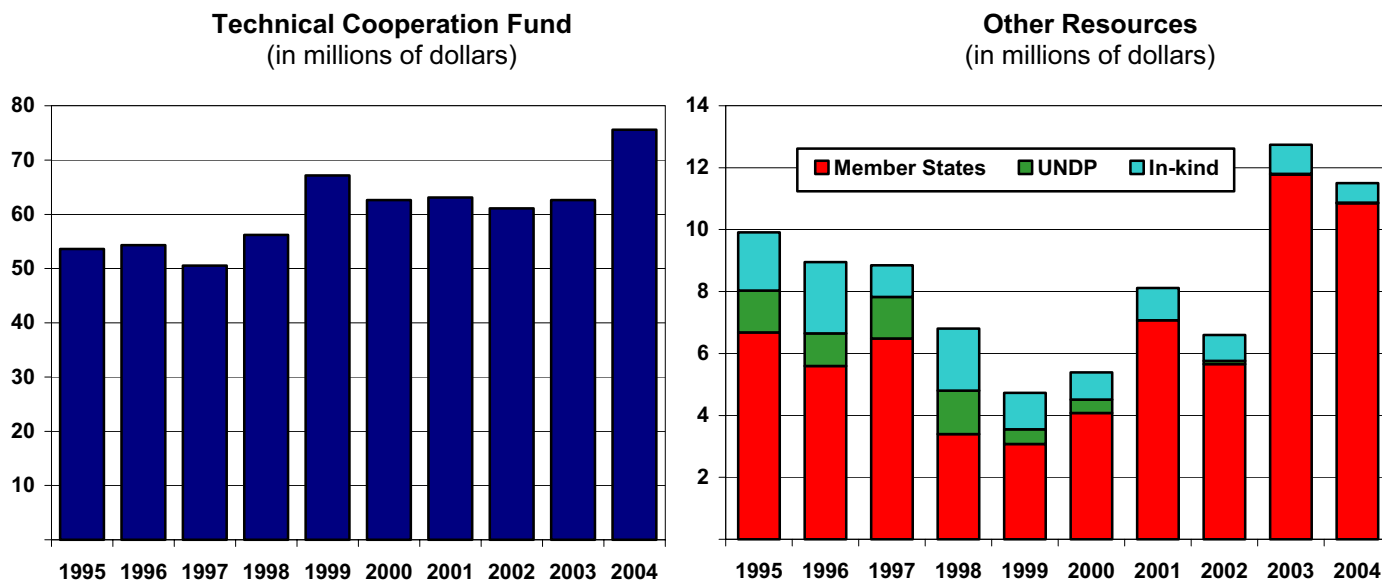
This table shows the in-kind support provided by 65 Member States and four international organizations. For in-kind support, the resources and delivery are equal.

AVAILABLE RESOURCES: 1995–2004

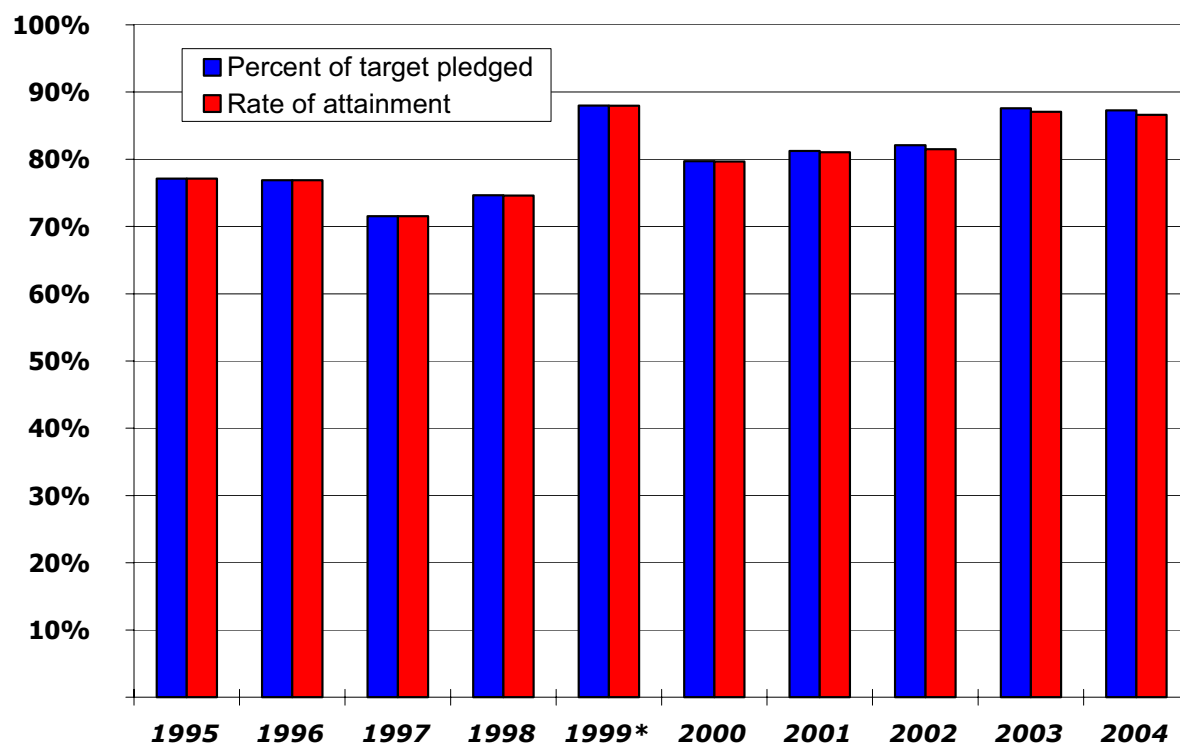

B. Disbursement and Implementation Summaries

Table B.1 Disbursement summary: 2004

In 2004, it also included a charge for radiation protection services totaling \$114 400.

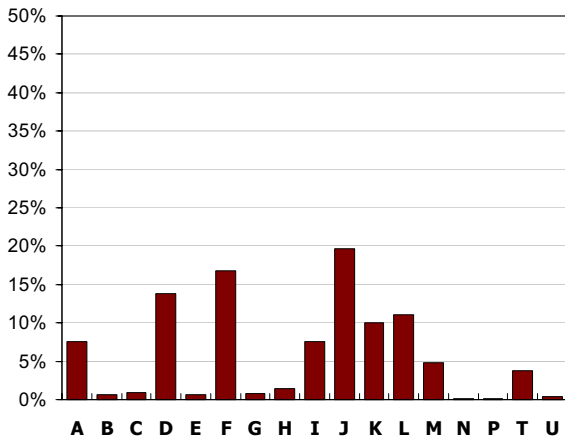

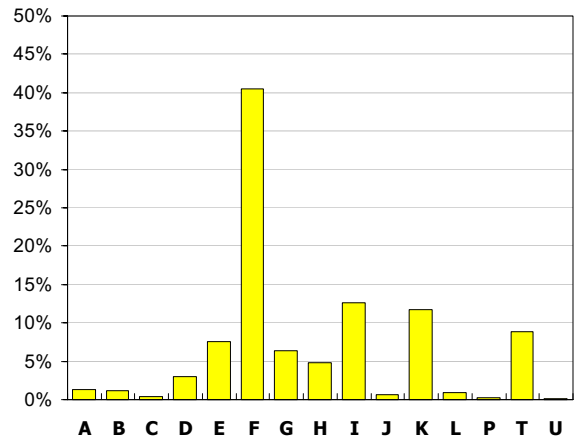
East Asia and the Pacific: \$11 475.9



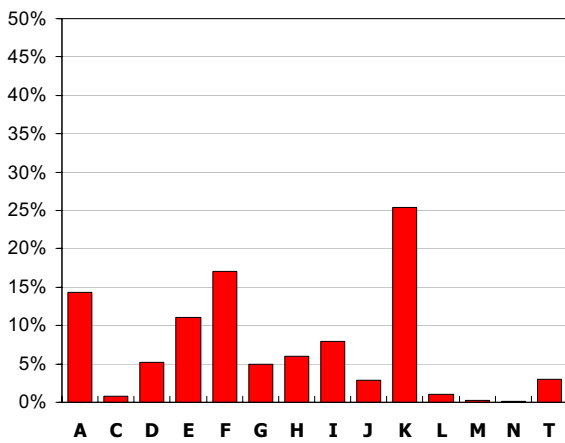

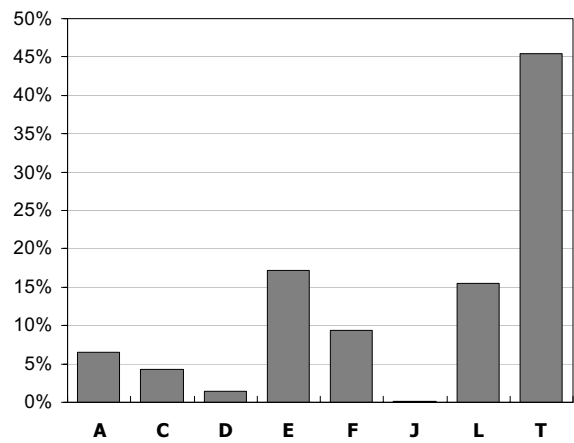

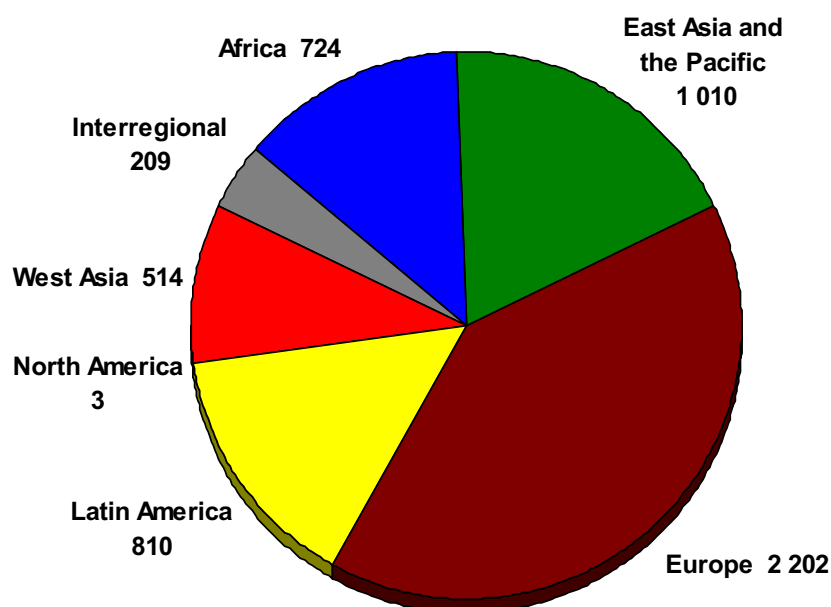
