## **Explanatory Note**

## Security Management and Security Plans for Radioactive Material and Associated Facilities (NST024)

The draft text for review, entitled *Security Management and Security Plans for Radioactive Material and Associated Facilities*, was prepared as a draft Technical Guidance to be issued in the IAEA Nuclear Security Series and has already been reviewed through consultants' meetings, as well as by the Nuclear Security Guidance Committee (NSGC).

The objective of this draft text, as accepted by the NSGC, is to provide guidance to States, regulatory bodies and operators on how to implement and maintain security management measures for radioactive material, associated facilities and activities, including guidance for the development of a security plan for radioactive material in use and storage and for associated facilities. This draft text is also intended to assist regulatory bodies in establishing regulations and guidance on security management and to assist operators in meeting these regulatory requirements.

Comments are requested in relation to:

- Relevance and usefulness Are the stated objectives appropriate, and are they met by the draft text?
- Scope and completeness Is the stated scope appropriate, and is it adequately covered by the draft text?
- Quality and clarity Does the guidance in the draft text represent the current consensus among specialists in the field, and is it expressed clearly and coherently?
- Appropriateness of guidance on safety–security interfaces Are the paragraphs of the draft text that address interfaces between safety and nuclear security appropriate?

Comments of an editorial nature will be considered; however, it should be noted that the draft text will be comprehensively edited by the IAEA Secretariat.

Any comments should be made in English, should refer to the relevant paragraph number in the draft text being reviewed, and should propose alternative text where appropriate. Please use the attached Form for Comments to record all comments.
