Initiated in 2011 as part of the IAEA Action Plan on Nuclear Safety, the Nuclear Operators' Forum is held every year alongside the IAEA General Conference, addressing different issues of importance to the safe and sustainable operation of nuclear power plants.

The 2019 Nuclear Operators' Forum will provide an opportunity for Member States to share and discuss current and future challenges related to the management of the *nuclear supply chain*. Representatives from nuclear operating organizations in Member States and international organizations will address global and local aspects of the nuclear supply chain and discuss avenues for managing innovations from the nuclear operator's perspective.

The discussion will cover quality control and assurance, oversight, sustainability, spare part inventory and reliability of the nuclear supply chain in Member States with operating nuclear power plants. The discussion may also include various engineering challenges such as counterfeit and fraudulent items, unidentified design issues, and use of commercial grade items.
