Notes: The Convention was opened for signature on 20 September 1994 and entered into force on 24 October 1996, in accordance with Article 31, paragraph 1. For each State or regional organization depositing an instrument expressing consent to be bound after that date, the Convention enters into force on the ninetieth day after the date of such deposit, in accordance with Article 31, paragraph 2.
