All statements received will be made available on the <u>Conference website</u> in PDF format, unless the distribution is restricted by the delegation. In that case, this should be clearly marked on the statement. Hard copies of the statements made during the Conference will not be distributed.

Ballot to determine the Speaking Order

As announced in the Secretariat's Note 2022/Note55, a ballot will be held on **Tuesday**, **6 September 2022** from **10 a.m. to 11 a.m. in Board Room C**, in the C Building at the VIC, 4th floor, to determine the order in which speakers will deliver their national statements during the Conference. After this date, requests for inscription in the list of speakers may be made directly, either in person or in writing, to the Conference Coordinator (Ms Martina Neuhold, email: <u>IAEA.Ministerial-Conference@iaea.org</u>, Tel: +43 1 2600-21314).

Ministers and Heads of Delegation will speak in the order determined by the speakers' ballot following the practice of giving priority to Ministers.

Visas

Participants representing foreign governments who are traveling for bilateral purpose as well as IAEA activities require an A-1 or A-2 type visas to attend the ministerial. Participants traveling on behalf of a foreign government for IAEA activities require a G-1, G-2, or G-3 visa and representatives traveling on behalf of design ated international organizations require a G-4 visa to attend. Participants from the private sector or non-

governmental organizations who are not U.S. citizens must apply for a Nonimmigrant B-1 Business Visa or Electronic System for Travel Authorization (ESTA). Please review the latest visa regulations on the U.S. Embassy/Consulate Website for your country of residence. You will find all official U.S. Embassies and Consulates on this <u>website</u>. Approval of your visa may require additional administrative processing, which adds additional time to normal processing from the time you submit an application. In order to meet the proposed arrival date, it is recommended you apply for your visa as-soon-as-possible, at least several weeks in advance of your travel and earlier if possible. Please note that the wait times for B visas remains long as a result of the pandemic. If you apply and receive a visa appointment date beyond that of the event, you can request an expedited appointment using the U.S. Embassy website where you applied.

Accommodation

Participants are expected to make their own travel and hotel arrangements. Please note that the IAEA cannot assist you with hotel bookings and cannot be held responsible for any cancellation fees or re-bookings.
