

## Joint Protocol Relating to the Application of the Vienna Convention and the Paris Convention

Notes: The Joint Protocol was adopted on 21 September 1988 and entered into force on 27 April 1992, in accordance with Article VII. For States depositing an instrument expressing consent to be bound after that date, the Joint Protocol enters into force three months after the date of such deposit.

2 The instrument of acceptance specifies that acceptance is "for the Kingdom in Europe".

3 On 7 July 1992, the Republic of Slovenia had deposited a notification of succession to the Vienna Convention on Civil Liability for Nuclear Damage, with effect from 25 June 1991. On 9 November 2001, the Republic of Slovenia notified the Depositary of the termination of the application of the Vienna Convention for the Republic of Slovenia and of the Republic of Slovenia's accession to the Paris Convention on Third Party Liability in the Field of Nuclear Energy. Pursuant to Article XXV.2 thereof, the Cienna Convention ceased to apply to Slovenia as of 12 November 2002.
