

Convention on Nuclear Safety

Organizational Meeting of Contracting Parties

24-25 September 2007
Report of the Chair

1. The Organizational Meeting, pursuant to Rule 11 of the Rules of Procedure and Financial Rules of the Convention (INFCIRC/573/Rev.1), was held at the Headquarters of the International Atomic Energy Agency (IAEA) in Vienna, 24-25 September 2007. Forty four out of 60 Contracting Parties participated, namely: Argentina; Armenia; Austria; Bangladesh; Belarus; Belgium; Brazil; Bulgaria; Canada; China; Croatia; Czech Republic; Denmark; EURATOM; Finland; France; Germany; Hungary; India; Indonesia; Ireland; Italy; Japan; Republic of Korea; Lithuania; Luxembourg; Mexico; Netherlands; Norway; Pakistan; Poland; Romania; Russian Federation; Singapore; Slovakia; Slovenia; South Africa; Spain; Sweden; Switzerland; Turkey; Ukraine; United Kingdom and United States of America. A list of participants is attached as Annex I.
2. Ms. Linda J. Keen, President of the Canadian Nuclear Safety Commission, Canada, was elected Chair of the Organizational Meeting.
3. Ms. Linda J. Keen presented perspectives from the President of the 3rd Review Meeting of the Contracting Parties.
4. The Meeting adopted the proposed agenda as shown in Annex II.
5. The Secretary examined the credentials of participating delegations as communicated by Contracting Parties. Under Rule 8 of the Rules of Procedure and Financial Rules, the Meeting approved all the communications listing delegates as presented by the Contracting Parties participating in the Organizational Meeting on the understanding that some delegations would provide the Secretariat with formal credentials as soon as possible. In this context the Chair noted the importance of a timely submission of proper credentials in accordance with Rule 8 of the Rules of Procedure and Financial Rules to the Secretary of the Meeting.
6. The Meeting elected Mr. Maurice T. Magugumela of South Africa as President of the 4th Review Meeting and Ms. Ann McGarry of Ireland and Mr. Juan Eibenschutz of Mexico as Vice-Presidents. The biographies of the President and Vice-Presidents are contained in Annex III.
7. Pursuant to Rule 5 of the Rules of Procedure and Financial Rules, the Chair appointed Mr. T. Taniguchi, Deputy Director General, Head of the Department of Nuclear Safety and Security, as Secretary to the Meeting, to direct the work of the Secretariat.
8. The Meeting, noting that the Nuclear Energy Agency of the Organisation for Economic Co-operation and Development (OECD/NEA) had requested to take part as an observer to the 4th Review Meeting, decided to invite the OECD/NEA.

9. The Meeting decided that interpretation will be provided during all plenary sessions of the 4th Review Meeting in Chinese, English, French, Russian and Spanish. The Meeting noted that no Contracting Party requested interpretation in Arabic. Therefore, the Meeting decided that Arabic interpretation will not be provided.

10. Pursuant to Rule 11 of the Rules of Procedure and Financial Rules, the Meeting decided to recommend a budget for the 4th Review Meeting as contained in Annex IV, noting that such a budget would make it possible to accommodate requests for interpretation filed pursuant to Rule 41.5(a) and Rule 41.5 (b) of the Rules of Procedure and Financial Rules.

11. The Meeting decided to use the list of Contracting Parties and their nuclear installations, as amended in the meeting and attached as Annex V, as a basis for establishing Country Groups. The Meeting then decided to establish six (6) Country Groups for the 4th Review Meeting. Pursuant to Rule 17 of the Rules of Procedure and Financial Rules, the Meeting allocated Contracting Parties to country groups based on a ranking of the number of nuclear installations, using a tennis-seeding method. Contracting Parties without nuclear installations were added to country groups, starting where assignment of State Parties with nuclear installations ended. The first such Contracting Party was Chile (the initial letter of whose name was randomly selected by a drawing), with the others added in alphabetical order. This procedure resulted in the composition of the Country Groups listed in Annex VI, which was agreed by the Meeting.

12. The Country Groups, thus established according to paragraph 11 above, then met separately and, pursuant to Rule 11 of the Rules of Procedure and Financial Rules, discussed nominations for Country Group Coordinators and Officers of the 4th Review Meeting.

13. Based on the discussions in the Country Groups, and pursuant to Rule 11 of the Rules of Procedure and Financial Rules, the Meeting:

a. elected Country Group Coordinators as follows:

it being understood that, if for some reason, the individual elected is unavailable, the Contracting Party concerned would nominate a replacement and notify the Secretary accordingly.

- c. To ensure that in accordance with Rule 11 (c) of the Rules of Procedure and Financial Rules no Rapporteur or Chairperson is assigned to the country group of which he/she is a member, the Meeting drew numbers to advance Chairpersons and Rapporteurs respectively to the corresponding groups. The number drawn for Chairpersons was 5 so that the designated Chairpersons would advance by five country groups. The number for Rapporteurs was 2, so that Rapporteurs would advance by two Country Groups.

14. The Meeting also decided that:

- a. An Officers' Meeting, chaired by the President of the 4th Review Meeting, will be held in March 2008 (tentatively scheduled for 10–11 March 2008) in Vienna to consider questions received and to review the overall approach in respect to Country Group discussions. The actual meeting dates will be confirmed by the Secretariat, in consultation with the President of the Review Meeting, by the end of October 2007.
- b. The General Committee of the 4th Review Meeting, consisting of the President, the Vice-Presidents and the Country Group Chairs, will meet on the afternoon of 13 April 2008. This will be immediately followed by a meeting of all Officers for the Review Meeting to finalize a consistent approach to the detailed review process, taking into account any trends in the questions and comments of the Contracting Parties on national reports and to agree upon the approach to reporting the groups' findings at the main plenary session.
- c. National contact points for submitting questions and comments on the national reports, including an e-mail address, should be communicated to the Secretary not later than Friday, October 19, 2007. At the same time, contact points should request a user name and password from the Secretariat for access to the CNS website.

- d. National reports received by the Secretariat should be distributed to Contracting Parties, through their Missions in Vienna not later than Monday, October 8, 2007. Contracting Parties are encouraged to make their national reports publicly available on the Internet and inform the Secretariat, preferably before October 19, 2007, of their relevant public Website addresses. Similarly, the Secretariat will provide links on the IAEA public website to the national reports mentioned above.
- e. It was decided not to hold a special topical session during the 4th Review Meeting.
- f. The meeting discussed what actions could be taken should a Contracting Party not submit a National Report. It was noted that Contracting Parties have an obligation to submit a National Report, even if the report is short in nature. The Meeting also strongly encouraged Contracting Parties to advise the Secretary at the earliest convenience whether they intend to make a presentation during the country group sessions.
- g. If Contracting Parties have not already done so, they should submit their national reports electronically to the Secretariat by September 28, 2007. The Secretariat will send letters of reminder to all Contracting Parties who have not filed their reports by October 19, 2007.

15. The Meeting noted with appreciation the Synopsis Paper and Issues and Trends Paper prepared by the Secretariat. Contracting Parties are encouraged to send reflections on the usefulness of these documents in the preparation of their National Reports to the Secretariat.


16. The Meeting briefly discussed a number of Contracting Party proposals to further enhance the review process. The Meeting agreed to refer all of these proposals to the Open Ended Working Group (OEWG) for elaboration. Contracting Parties should send proposals to the CNS Coordinator in the Secretariat who will post them on the CNS website for further development by Contracting Parties.

17. The Meeting also noted that there were changes put in place by the 3rd Review Meeting and requested that the Secretariat post the applicable changes on the CNS Website.

18. The Meeting decided on the Agenda for the 4th Review Meeting as contained in Annex VII. A provisional timetable for the 4th Review Meeting is included in Annex VII. The final timetable will be issued by the Secretariat by the end of October 2007.

19. The Meeting requested the Secretary to transmit the Report of the Chair of the Organizational Meeting and its Annexes to the Director General of the IAEA, thereby informing him of the decisions taken at the Meeting for consideration in the IAEA budgetary process, as foreseen in Article 28 of the Convention.

20. Finally, the Meeting agreed on this Report by the Chair of the Organizational Meeting, and requested the Secretary to transmit the report, and its Annexes, to the Contracting Parties and the Signatory States, noting that the Secretariat could make this report and a list of the Annexes publicly available.

Biography of Mrs. Ann McGarry (Chief Executive of the RPII)

Dr Ann McGarry studied physics at the Dublin Institute of Technology and University College Dublin. She was awarded a Masters Degree in Applied Physics in 1986 and a Ph.D. in Experimental Physics in 1991 by University College Dublin. She has worked for the Radiological Protection Institute of Ireland (RPII) (and its forerunner the Nuclear Energy Board) since 1985. The RPII is the national regulatory authority in Ireland with regulatory, monitoring and advisory responsibilities in all matters relating to ionizing radiation.

Since 1994, Dr McGarry has held senior management responsibility at various times for the RPII's work on regulation of the uses of ionizing radiation in medicine and industry, radon in buildings and monitoring of radiation doses received by workers. She was appointed Chief Executive of the RPII in May 2002.

During her career, Dr McGarry has represented Ireland or served as an expert on various international committees with remits in radiation protection and nuclear safety. At present, she is Member of Committee 4 (Application of the Commission's recommendations) of the International Commission on Radiological Protection (ICRP), the international body established to advance for the public benefit the science of radiological protection. She represents Ireland on the Steering Committee of the Nuclear Energy Agency (NEA) and on the NEA's Committee on Radiation Protection and Public Health (CRPPH). She was elected to the CRPPH Bureau in 2003 and in May this year chaired the 50th Anniversary Conference of the CRPPH. She has recently been nominated to represent Ireland on the High Level Group on Nuclear Safety and Waste Management established by the European Commission.

In Ireland, she has served on the Consultative Council to the Irish Food Safety Authority and as a member of the Civil Defence Board. In 2006, she was awarded an Honorary Doctorate by the Dublin Institute of Technology for services to science.
