PROVISIONAL SCALE OF CONTRIBUTIONS FOR 1958
RESOLUTION ADOPTED DURING THE 11th PLENARY MEETING ON 22 OCTOBER 1957

The General Conference

Resolves that:

- 1. The scale for the apportionment of the administrative expenses among the Members for the financial year 1958 shall be provisional and shall be subject to retroactive adjustment by the General Conference during its second regular session in the light of the then existing membership:
- 2. In order to give effect to Article XIV.D. of the Statute, the administrative expenses of the Agency for the financial year 1958 shall be apportioned broadly according to capacity to pay and the provisional scale for 1958 shall be based upon the scale adopted by the United Nations for 1957 adjusted to take account of the different membership of the Agency, provided that:
 - (a) The rate of contribution of the Member which bears the highest assessment shall be set at 33-1/3 per cent of the total assessment:
 - (b) The rate of contribution of the Members bearing the smallest shares of assessment shall be set at 0.04 per cent of the total assessment; and that
 - (c) The per capita contribution of any Member shall not exceed the per capita contribution of the Member which bears the highest assessment;
- 3. In the provisional scale for 1958, the rates of contribution of Members which are not included in the scale adopted by the United Nations for 1957 shall be based upon the information obtained from the United Nations Secretariat and set forth in document GC.1/INF/5, adjusted in accordance with paragraph 2 of this resolution;
- 4. New Members depositing instruments of ratification between 15

October 1957 and the second regular session of the General Conference shall be assessed provisionally in accordance with Article 6.08 of the Provisional Financial Regulations, subject to retroactive adjustment and inclusion in the revised scale of assessments for 1958 to be adopted by the General Conference at its second regular session; and
