## Memorandum by the Director General

1. Under Rule 42 of the Rules of Procedure, the General Committee is required to report to the General Conference on the provisional agenda for the session and on the supplementary list of items provided for in Rule 13, as well as to propose the allocation of agenda items to Committees. The provisional agenda is given in document GC(II)/35; but as is pointed out in addendum 1 to that document, there is no supplementary list of items because the Director General received no request for the inclusion of supplementary items in the agenda within the prescribed time limit. The Director General further wishes to inform the Committee that at the time of drafting the present memorandum, no proposal under Rule 15 for the inclusion of any additional item in the agenda had come to his attention.

2. In the annotations to the provisional agenda suggestions were made as to where each item should first be discussed, either in plenary meeting or in one of the committees. In the opinion of the Director General, there have been no developments since those suggestions were put forward that would make it desirable to modify them, except in the case of one item -"17. Measures to obtain voluntary contributions to the General Fund including the calling of a pledging conference."

3. The original suggestion was that this item should initially be referred to the Programme, Technical and Budget Committee. It now appears, however, that it would be desirable for the matter to be considered in plenary meeting GC(II)/GEN/4 Page 2

earlier than would be practicable were it first to be taken in committee; and the Director General suggests that the Committee may wish to make a proposal in this sense to the General Conference.

4. A draft of the Committee's report to the General Conference on the provisional agenda, based on the assumption that the Committee may wish to recommend the General Conference to approve the provisional agenda and the allocation of items proposed by the Director General, is annexed to this memorandum for the Committee's convenience.

ADOPTION OF THI AGINDA AND ALLOCATION OF IT I'S TO COMMITTIES

Report by the General Committee under Rule 42 of the Rules of Procedure

1. At its third meeting on 23 September 1953 the General Committee considered the provisional agenda for the second regular session.  $\frac{1}{}$ 

2.
