SCALE OF MEMBERS' CONTRIBUTIONS

Resolution adopted during the 24th plenary meeting on 4 October 1958

PROVISIONAL SCALE OF CONTRIBUTIONS FOR 1959

The General Conference,

1. Resolves that the scale for the apportionment of the administrative expenses among the Members for the financial year 1959 shall be provisional and shall be subject to retroactive adjustment by the General Conference during its third regular session in the light of the decision of the United Nations General Assembly on the United Nations scale of assessment for 1959, and in accordance with the number of members of the Agency at the time of the third regular session.
2. In order to give effect to Article XIV.D. of the Statute, the administrative expenses of the Agency for the financial year 1959 shall be apportioned broadly according to capacity to pay and the provisional scale for 1959 shall be based upon the scale adopted by the United Nations for 1958 adjusted to take account of the different membership of the Agency, provided that:
  - (a) The rate of contributions of the Member which bears the highest assessment shall be set at 32.51 per cent of the total assessment and shall remain at that percentage in any final scale for 1959 which may be adopted by the General Conference in its third regular session;
  - (b) The rate of contribution of the Members bearing the smallest shares of assessment shall be set at 0.04 per cent of the total assessment,

shall remain at that percentage in any final scale for 1959 which may be adopted by the General Conference in its third regular session; and that

- (c) The per capita contribution of any Member shall not exceed the per capita contribution of the Member which bears the highest assessment.

3. In the provisional scale for 1959, the rates of contributions of Members which are not included in the scale adopted by the United Nations for 1958 shall be based upon the information obtained by the Director General from the United Nations Secretariat, adjusted in accordance with paragraph 2 of this resolution.
4. New Members depositing instruments of ratification between 1 September 1958 and the third regular session of the General Conference shall be assessed provisionally in accordance with Article 6.08 of the Financial Regulations, subject to retroactive adjustment and inclusion in the revised scale of assessment for 1959 to be adopted by the General Conference at its third regular session.
5. The provisional scale for 1959 should be as follows:
