### ELECTION OF MEMBERS TO THE BOARD OF GOVERNORS

#### Memorandum by the Director General

1. Under Rule 86 of the Rules of Procedure<sup>1/</sup> the General Committee is called upon to determine the number of elective places on the Board of Governors which must be filled by the General Conference, as well as to specify each geographical area in respect of which a Member or Members must be elected so as to ensure compliance with the provisions of Article VI.A.3 of the Statute.
2. Of the present Members elected at previous sessions, the terms of office of five - Brazil, Indonesia, Iran, Italy and Mexico - will expire at the end of the eighth regular session. The Committee will, therefore, no doubt wish to determine and so report to the Conference that five Members must be elected to the Board during this session.
3. Article VI.A.3 of the Statute provides that the 12 Members of the Board elected by the General Conference shall always include:
 

3 from Latin America,	1 from South Asia,
1 from Western Europe,	1 from South East Asia and the Pacific, and
1 from Eastern Europe,	1 from the Far East.
3 from Africa and the Middle East,	

Since the seven Members that will continue to serve on the Board after the end of the current session are Afghanistan, China, Congo (Leopoldville), Morocco,

Romania, Switzerland and Uruguay<sup>2/</sup>, the Committee will doubtless wish to specify that the following elections are required in respect of geographical areas:

2 from Latin America,	1 from South East Asia
1 from Africa and the Middle East, and	and the Pacific.

4. For the Committee's convenience, a draft of its report to the Conference is annexed hereto. It closely follows the lines of the corresponding report the Committee made to the Conference last year<sup>3/</sup>.

ELECTION OF MEMBERS TO THE BOARD OF GOVERNORS

Report by the General Committee

1. Rule 86 of the Rules of Procedure<sup>1/</sup> requires the General Committee to determine the number of elective places on the Board of Governors which must be filled by the General Conference so as to ensure compliance with the provisions of Article VI.A.3 of the Statute. The Committee accordingly notifies the Conference that it has determined that five Members must be elected to the Board during the present session. In this connection the Committee invites attention to the last provision in the Article, which stipulates that

" . . . no member in the category of members elected to the Board by the General Conference in any one term of office will be eligible for re-election in the same category for the following term of office."<sup>2/</sup>

2. Rule 86 further requires the General Committee to specify the geographical areas in respect of which a Member or Members must be elected so as to ensure that after the end of the session the Board shall include three Members elected by the General Conference from each of the areas of Latin America and of Africa and the Middle East, and one Member from each of the remaining areas, except North America, specified in Rule 83. In compliance with this provision, the Committee hereby specifies that elections are required at the current session in respect of three geographical areas, as follows:

- 2 Members from Latin America,
- 1 Member from Africa and the Middle East, and
- 1 Member from South East Asia and the Pacific.

The remaining Member may be elected from any geographical area in so far as its election is not precluded by the provisions of Article VI of the Statute.

3. In view of the provision in Rule 83 that the General Conference shall conduct the elections with due regard to equitable representation on the Board as a whole of the Members in the geographical areas specified in that Rule, it may wish to have before it the following list of Members that have already been designated by the Board<sup>3/</sup> or elected by the Conference<sup>4/</sup> to serve on the Board after the end of the present session:
