### ADOPTION OF THE AGENDA AND ALLOCATION OF ITEMS FOR INITIAL DISCUSSION

#### Report by the General Committee under Rule 42 of the Rules of Procedure

1. At its thirteenth meeting on 21 September 1965, the General Committee considered the provisional agenda for the current session.<sup>1/</sup>
2. In the light of a communication from the Board of Governors on item 18 - Amendment of Article VI.A.2 of the Statute; Proposal by the Democratic Republic of the Congo<sup>2/</sup>, the Committee concluded that it would be desirable for consideration of the issues raised by the proposal to be deferred, foreseeing the likelihood of the Conference taking up the matter at its session next year. The Committee accordingly recommends that this item should not be included in the agenda for the current session.
3. Since no action is needed at this session in relation to emergency assistance in the event of radiation accidents, the Committee further recommends that item 19 should not be included in the agenda.
4. The Committee recommends to the Conference that the remaining items on the provisional agenda be included in the agenda.
5. Insofar as the allocation of agenda items for initial discussion is concerned, the Committee is in agreement with the suggestions made in document GC(IX)/295 and accordingly recommends that the items be so allocated for initial discussion.
6. The recommendations thus made by the Committee are summarized overleaf.
