2. <u>Decides further</u> that any State that becomes a Member of the Agency during the remainder of 1967 or in 1968 shall be assessed as appropriate for contributions to the Agency's Regular Budget for these years, and for its advance to the Working Capital Fund, by applying to its United Nations percentage the appropriate coefficient used to determine the scales for assessment of Members' contributions for 1967 and 1968.
