APPLICATIONS FOR MEMBERSHIP OF THE AGENCY

Applications by Liechtenstein and Zambia

Recommendations by the Board of Governors

1. The following communications, which were received by the Director General from Liechtenstein and from Zambia, were brought to the attention of the Board of Governors on 18 April and 10 June 1968 respectively:

Letter from the Head of Government of the Principality of Liechtenstein

"20 March 1968

"I have the honour to request the International Atomic Energy Agency that it admit the Principality of Liechtenstein as a Member.

"On behalf of the Government of the Principality of Liechtenstein, I should like to assure the Agency of the desire of the Principality of Liechtenstein to fulfil the obligations of Member States of the Agency in accordance with the Agency's Statute and with the Purposes and Principles of the Charter of the United Nations."

Telegram dated 6 June 1968 from the Regional Representative of the United Nations Development Programme in South East Africa, from Lusaka in Zambia [1]

". . . GOVERNMENT REPUBLIC ZAMBIA PRESENTS COMPLIMENTS IAEA . . . AND SEEKS MEMBERSHIP AND AGREES ABIDE BY TERMS AND CONDITIONS OF STATUTE . . ."

2. On 13 June the Board considered these two applications for membership of the Agency in the light of Article IV. B of the Statute, and determined that Liechtenstein and Zambia were able and willing to carry out the obligations of membership of the Agency and to act in accordance with the purposes and principles of the Charter of the United Nations. The Board accordingly recommends the Conference to approve both States for membership of the Agency, and submits the two draft resolutions below for the consideration of the Conference.

Draft resolution A

APPLICATION BY LIECHTENSTEIN FOR MEMBERSHIP OF THE AGENCY

The General Conference,

- (a) Having received the recommendation of the Board of Governors that Liechtenstein should be approved for membership of the Agency, [*] and
- (b) Having considered Liechtenstein's application for membership in the light of Article IV. B of the Statute,

Approves Liechtenstein for membership of the Agency.

Draft resolution B

APPLICATION BY ZAMBIA FOR MEMBERSHIP OF THE AGENCY

The General Conference,

- (a) Having received the recommendation of the Board of Governors that Zambia should be approved for membership of the Agency, [*] and
- (b) Having considered Zambia's application for membership in the light of Article IV. B of the Statute,

Approves Zambia for membership of the Agency.
