### THE AGENCY'S ANNUAL REPORTS TO UNITED NATIONS ORGANS

#### Recommendations by the Board of Governors

1. The General Conference will be aware that by now there are standardized procedures for preparing and transmitting to the United Nations the reports which the Agency is called upon to make each year to the General Assembly and the Economic and Social Council. The report to the Assembly consists of the annual report of the Board of Governors to the Conference together with a supplement, for the preparation of which the Board customarily arranges, to bring the Board's report up to date; [ 1 ] the report to the Council covers the year ending on 31 March [ 2 ] and is submitted to it as soon as practicable thereafter.
2. The Board considers that these procedures should continue to be followed, and accordingly recommends the Conference to adopt the two draft resolutions overleaf.

THE AGENCY'S REPORT TO THE GENERAL ASSEMBLY OF THE  
UNITED NATIONS FOR 1968-69

The General Conference,

Bearing in mind Resolution GC(IV)/RES/61 relating to the Agency's annual report to the General Assembly of the United Nations,

Requests the Board of Governors to arrange for the preparation of a supplement to its annual report to the General Conference for 1968-69 [\*] which, together with that report, shall constitute the Agency's report to the General Assembly of the United Nations for that year .

Draft resolution B

THE AGENCY'S REPORT TO THE ECONOMIC AND SOCIAL COUNCIL  
OF THE UNITED NATIONS FOR 1969-70

The General Conference,

(a) Recalling its decision that the Agency should submit a report to the Economic and Social Council of the United Nations for consideration at the Council's second session each year, [\*] and

(b) Recalling also the authorization it has given to the Board of Governors in the past to submit this annual report direct to the Council, [\*\*]

Authorizes the Board of Governors to submit the Agency's annual report to the Economic and Social Council of the United Nations for 1969-70 direct to the Council.
