#### SCALE OF MEMBERS' CONTRIBUTIONS FOR 1971

## Memorandum by the Director General

- 1. The Director General submits herewith a draft resolution whereby the General Conference could set the scale for assessment of Members' contributions to the Agency's Regular Budget for 1971. Following the usual practice[1], the scale is based on the United Nations scale for 1970[2]. It takes account of the fact that 103 States were Members of the Agency on 31 August[3], one more than on the same date last year, the new Member being Ireland.
- 2. Numerical data used in elaborating the scale are reproduced in the Annex to the present document. The procedure that would be followed for assessing the contributions of any State that became a Member of the Agency after the scale had been adopted is set out in paragraph 2 of the draft resolution.

# SCALE OF MEMBERS' CONTRIBUTIONS FOR 1971

## The General Conference

2. <u>Decides further</u> that any State that becomes a Member of the Agency during the remainder of 1970 or in 1971 shall be assessed for its advance to the Working Capital Fund and for contributions to the Agency's Regular Budgets for these years, by applying to its United Nations percentage assessment as appropriate the coefficient used to calculate the scales for the assessment of Members' contributions for 1970 and 1971[\*] respectively.

# B. Method of calculating the coefficient 0.9054

- 1. From the foregoing table it will be noted that on the United Nations scale for 1970, the total percentage assessments of Members of the Agency that are also Members of the United Nations amounts to 98.96%. The assessments recommended by the United Nations for the Agency's Members that are not members of the United Nations amounts to 8.18%, making a total of 107.14%.
- 2. It is therefore necessary to establish a coefficient by which to multiply the assessments so as to decrease the total to 100.00%, bearing in mind that in the light of a decision of the General Conference[1], it will not be applied:
  - (a) To the percentage of the Member bearing the maximum rate of assessment. This was set at 31.50% in the scale for 1970[2]. In the scale for 1971 that Member's percentage has been reduced by applying to it a proportional share of the assessment of the new Member. This has resulted in a new assessment of 31.45% for the Member in question without increasing the rate for any other Member; and
  - (b) In the case of the following 34 Members that bear the minimum rate of assessment of 0.04%, and whose assessments accordingly total 1.36%:
