## REPORT ON VOLUNTARY CONTRIBUTIONS PLEDGED FOR THE TECHNICAL ASSISTANCE FUND FOR 1982

### Memorandum by the Director General

1. By 6 p.m. on 24 September 55 Members of the Agency had pledged voluntary contributions for the Technical Assistance Fund for 1982 as shown in the table overleaf.
2. When the Conference takes up this item of its agenda, the President will report on the contributions for the Technical Assistance Fund for next year that have then been pledged. In order to expedite matters, the delegates of those Members that have not yet made a pledge are invited to communicate their Governments' pledges as soon as possible to the officer who sits during plenary meetings at a table marked "Voluntary contributions" and who will at other times be at a table similarly identified in the Zeremoniensaal.
