CONSEQUENCES OF THE ISRAELI MILITARY ATTACK ON THE IRAQI NUCLEAR RESEARCH REACTOR AND THE STANDING THREAT TO REPEAT THIS ATTACK FOR;

(a) THE DEVELOPMENT OF NUCLEAR ENERGY FOR PEACEFUL PURPOSES: AND (b) THE ROLE AND ACTIVITIES OF THE INTERNATIONAL ATOMIC ENERGY AGENCY

Draft resolution submitted by Iraq

The General Conference,

- (a) Having considered agenda item 10,
- (b) Taking note of Security Council resolution 487 unanimously adopted on 19 June 1981, which, inter alia, called upon Israel to refrain in the future from any such acts or threats thereof, and urgently to place its nuclear facilities under IAEA safeguards,
- (c) Recalling resolution GC(XXVII)/RES/409 of 1983 which, inter alia, urgently called on Israel to withdraw forthwith its threat to attack and destroy nuclear facilities in Iraq and in other countries,
- (d) Recalling further resolution GC(XXVIII)/RES/425 of 1984 which, inter alia, demanded that Israel undertake forthwith not to carry out any further attacks on nuclear facilities in Iraq or on similar facilities in other countries, devoted for peaceful purposes, in disregard of the Agency's safeguards system,
- (e) <u>Convinced</u> that the stated Israeli threats to attack nuclear facilities in Iraq and in other countries will continue to endanger the role and activities of the Agency and other international instruments in the development of nuclear energy for peaceful purposes, and in safeguarding against further proliferation of nuclear weapons,
- (f) <u>Mindful</u> that all Iraqi nuclear installations are under Agency's safeguards,

- (g) <u>Taking note</u> of the report of the Director General of the International Atomic Energy Agency to this General Conference pursuant to paragraph 4 of resolution GC(XXVIII)/RES/425,
- (h) <u>Viewing with deep concern</u> Israel's refusal to comply with Security Council resolution 487 (1981) and General Conference resolutions GC(XXVII)/RES/409 and GC(XXVIII)/RES/425,
- 1. <u>Demands</u> again that Israel withdraw forthwith its stated threat to repeat its military attack against Iraqi nuclear installations and to undertake, without further delay to commit itself not to attack or threaten to attack nuclear facilities in Iraq;
- 2. <u>Decides</u> to implement immediately paragraph 3 of its resolution GC(XXVII)/RES/409 and to withhold Agency research contracts to Israel, to discontinue the purchase of equipment and materials from Israel and refrain from holding seminars, scientific and technical meetings in Israel;
- 3. Requests the Security Council to take urgent and effective measures to ensure that Israel complies without further delay with the provisions of resolution 487 (1981):
- 4. <u>Further requests</u> the Director General to report to the Board of Governors and the next session of the General Conference on the implementation of this resolution:
- 5. Reaffirms the inalienable right of all states to acquire and develop nuclear energy for peaceful purposes;
- 6. <u>Reaffirms</u> further its confidence in the effectiveness of the Agency safeguards system.
