THE FINANCING OF SAFEGUARDS

Resolution adopted during the 321st plenary meeting on 29 September 1989

ARRANGEMENTS FOR THE ASSESSMENT OF MEMBERS' CONTRIBUTIONS
TOWARDS THE SAFEGUARDS COMPONENT OF THE AGENCY'S REGULAR BUDGET
FOR EACH OF THE YEARS 1990, 1991 AND 1992

The General Conference,

- (a) Recalling its resolutions embodying principles for the assessment of Members' contributions towards the safeguards component of the Agency's Regular Budget 1 and operative paragraph 2 of resolution GC(XXX)/RES/462,
- (b) <u>Having considered</u> the Board's recommendation in document GC(XXXIII)/877 concerning the arrangements for the assessment of Members' contributions towards the safeguards component of the Agency's Regular Budget for each of the years 1990, 1991 and 1992,
- (c) <u>Believing</u> that the amendments now being approved to the existing arrangements should not prejudge whatever may be decided in the future, and
- (d) <u>Taking note</u> of the Board's intention to continue its efforts to arrive at long-term arrangements based on clearly defined elements for the financing of safeguards,

- 1. <u>Decides</u> that the arrangements for the assessment of Members' contributions towards the safeguards component of the Agency's Regular Budget which it approved in 1983 by resolution GC(XXVII)/RES/416 to supplement those contained in resolutions GC(III)/RES/50 and GC(XXI)/RES/351 and which were extended to be applicable for 1985 and 1986 (by resolution GC(XXVIII)/RES/433 adopted in 1984) and for 1987, 1988 and 1989 (by resolution GC(XXX)/RES/462 adopted in 1986) shall continue to be applicable for 1990, 1991 and 1992 with the following amendments:
 - (i) The contribution of each Member included in 1989 in the list of Member States qualifying to receive partial relief in respect of their assessments for the safeguards component of the Regular Budget2/ shall be increased by percentages equal to the price increase percentages on which the Regular Budget for each of the years 1990, 1991 and 1992 is based.3/
 - (ii) In the case of admission of a new Member of the Agency which is to be included in the list referred to in sub-paragraph (i) above, that Member shall contribute, in the year its membership becomes effective, and where applicable in succeeding years, an amount, or amounts, equal to what it would have had to contribute in 1989 (if it had been a Member) increased in accordance with the provisions set out in sub-paragraph (i) above.4/
- 2. These arrangements shall be reviewed by the Board in 1992 at the latest.
