MEASURES TO STRENGTHEN INTERNATIONAL CO-OPERATION IN MATTERS RELATING TO NUCLEAR SAFETY AND RADIOLOGICAL PROTECTION

CONVENTION ON EARLY NOTIFICATION OF A NUCLEAR ACCIDENT

and

CONVENTION ON ASSISTANCE IN THE CASE OF A NUCLEAR ACCIDENT OR RADIOLOGICAL EMERGENCY

Report by the Director General

- 1. In resolution GC(XXXIII)/RES/511, the Conference requested the Director General to report to it at its thirty-fourth regular session on the status and implementation of the Convention on the Early Notification of a Nuclear Accident (Early Notification Convention) and the Convention on Assistance in the Case of a Nuclear Accident or Radiological Emergency (Assistance Convention). Tables showing the status of the Conventions as of 31 July 1990 are attached.
- 2. On 18 January 1989, the Agency's Emergency Response System (ERS) was formally put into operation. Also, at that time the Secretariat distributed to Member States two manuals for use by them in implementing the ERS: an "Emergency Notification and Assistance Technical Operations Manual" (ENATOM) and a "Manual on the Use of the World Meteorological Organization (WMO) Global Telecommunication System (GTS) for the Early Notification Convention". 1/

- 3. There have been no notifications of nuclear accidents pursuant to the Early Notification Convention (i.e. no notifications of accidents of the kind specified in Article 1 of the Convention). However, several Member States have informed the Agency of situations which they felt should be brought to the attention of the Agency in the spirit of the Convention.
- 4. With regard to the Assistance Convention, the Agency has provided assistance under it following two radiological accidents: the radiological accident in Goiânia, Brazil, in which the misuse of an abandoned medical teletherapy source led to radiation injuries (resulting in four deaths) and to widespread contamination $\frac{2}{}$; the radiological accident at an industrial irradiation facility in San Salvador, El Salvador, which resulted in one death. $\frac{3}{}$
- 5. Within the Agency's Secretariat, a "Handbook of Emergency Response Procedures for the Emergency Response System" has been widely distributed and many staff members have been trained in the use of these procedures. A comprehensive ERS exercise was conducted on 19 April 1990; about 50 staff members were involved and five Member States and four other international organizations co-operated in it. The ERS will be modified in the light of the lessons learned from the exercise, further training will be provided and further exercises will be conducted from time to time.
- 6. Arrangements have been made with WMO and the World Health Organization (WHO) for them to support the Agency in the event of a nuclear accident involving their respective areas of expertise: WMO will provide predictions of the plume path and radioactive contamination in the event of an accidental release of radioactive materials; WHO will provide emergency assistance following radiological accidents.

7. The Agency's Secretariat has drafted "Guidance on the Handling of Information and Data following a Major Nuclear Accident" which will be reviewed by an Advisory Group in October 1990. It will in due course be distributed to all Member States for use in developing national procedures for implementing the Conventions.
