SCALE OF ASSESSMENT OF MEMBERS' CONTRIBUTIONS FOR 1992

1. The Director General submits herewith to the General Conference a draft resolution whereby the Conference is requested to set, in accordance with Article XIV.D of the Statute, the scale of assessment of Members' contributions to the Agency's Regular Budget for 1992. The scale annexed to the draft resolution has been prepared in accordance with the principles established by the General Conference [1]. The scale is based on the Agency's membership as of 31 July 1991.
2. With regard to the scale annexed to the resolution, 77 Members will receive partial relief in respect of their assessments for the safeguards component of the Regular Budget; these Members' individual assessments for the safeguards component will be increased by 5.2 per cent, which represents the price increase percentage on which the Regular Budget estimates for 1992 are based. The remaining 35 Members will continue to contribute on an increased basis as set forth in Table 3 of the Appendix hereto.
3. It will be noted that the following draft resolution would also provide for approval by the General Conference of the base rate of assessment of each Member. This has been derived from the scale which has been used by the United Nations to assess contributions from its Members to its Regular Budget for 1991 and which is adjusted in accordance with established procedures to compensate for differences in membership between the Agency and the United Nations.
4. The computations that were made in order to establish both the individual base rates and the resulting scale of assessment are reproduced for the information of the Conference in the Appendix.

5. Member States are urged to inform the Director General by 1 January 1992 as to when their Regular Budget contributions will be paid to the Agency. In the light of the information provided, the Secretariat will prepare cash forecasts on the basis of which the programme will be implemented.

Draft resolution

SCALE OF ASSESSMENT OF MEMBERS' CONTRIBUTIONS FOR 1992

The General Conference,

Applying the principles it has established for the assessment of Members' contributions towards the Agency's Regular Budget [*],

1. Decides that the individual base rates and the resulting scale of assessment of Members' contributions to the Agency's Regular Budget for 1992 shall be as set forth in the Annex hereto; and
2. Determines, pursuant to Financial Regulation 6.08 [**], that in the event of a State becoming a Member of the Agency during the remainder of 1991 or in 1992 it shall be assessed as appropriate:
 - (a) For an advance or advances to the Working Capital Fund, in accordance with Financial Regulation 7.03 [***]; and
 - (b) For a contribution or contributions towards the Agency's Regular Budget, in accordance with the principles the Conference has established for that purpose.

A P P E N D I X

MEMBERS' CONTRIBUTIONS TO THE AGENCY'S REGULAR BUDGET FOR 1992

The computation of the individual Regular Budget assessments

1. As a first step in computing the individual Regular Budget assessments, the Agency's Regular Budget for 1992 is divided into a "non-safeguards" component and a "safeguards" component [1]. The total assessment proposed is \$ 20 891 000 plus the equivalent in United States dollars of AS 1 935 578 000, which, at an exchange rate of AS 10.90 to \$ 1.00, amounts to \$ 198 467 000 [2]. Of this total the "non-safeguards" component amounts to \$ 12 620 000 plus the equivalent in United States dollars of AS 1 281 949 000 and the "safeguards" component to \$ 8 271 000 plus the equivalent in United States dollars of AS 653 629 000. (The latter component consists of the appropriation specifically proposed for safeguards less income of \$ 280 000 which it is estimated will be received from non-member States during 1992.)

2. The next step is to derive a base rate of assessment for each Member of the Agency on the basis of the scale used by the United Nations to assess contributions from its Members to its budgets for the years 1989-1991 [3]. This is done in Table 1.

3. It will be seen from the end of the foregoing table that the United Nations percentage assessments for Members of the Agency that were also Members of the United Nations amount to 99.38 per cent, and that the United Nations rates of assessment for the other Members of the Agency amount to 1.38 per cent. To the total figure of 100.76 per cent, obtained by combining these two percentages, a coefficient is applied to establish the base rates of assessment for all Member States of the Agency which will give a total of 100.00 per cent. In accordance with the principles established by the General Conference [4], however, the coefficient is not applied in the case of the Member bearing the highest United Nations assessment, nor of the 35 Members each bearing the lowest United Nations assessment. The coefficient is therefore calculated as follows:

It is now necessary to determine the respective shares of the safeguards component to be borne by the Members qualifying to receive partial relief in respect of their assessment for the safeguards component of the Regular Budget in accordance with the revised arrangements as set forth in resolutions GC(XXVII)/RES/416 and GC(XXXIII)/RES/512. The following list shows the Member States qualifying to receive partial relief and the dollar amount borne by each Member State.

5. It will be noted that the total amount of the safeguards assessments of the 77 Members listed in Table 2 has been increased to \$ 766 728. The difference is due to the the price increase of 5.2 per cent on which the Regular Budget estimates for 1992 are based. The remaining amount is borne by 35 Members, the share of each Member being calculated as shown in Table 3.
