REPORT ON VOLUNTARY CONTRIBUTIONS PLEDGED TO THE TECHNICAL CO-OPERATION FUND FOR 1996

1. The purpose of the following table is to inform delegates to the thirty-ninth regular session of the General Conference about the pledges of voluntary contributions to the Technical Co-operation Fund for 1996 made by Members of the Agency up to 5 p.m. on 15 September 1995.^[1]
2. It is foreseen that the Conference will consider the matter of voluntary contributions to the Technical Co-operation Fund in a plenary meeting at which the President will report on the contributions pledged by that time. Revisions of the present document will be issued as the session proceeds for the purpose of keeping the Conference informed of the pledges that Members are making.
3. Delegates who have not yet done so are invited to communicate their Governments' pledges as soon as possible to the officer who will be sitting during plenary meetings at a table marked "Voluntary Contributions" in the Plenary Hall at the Austria Center and who will at other times be in office A-443 on the second floor.
