## REPORT ON VOLUNTARY CONTRIBUTIONS PLEDGED TO THE TECHNICAL CO-OPERATION FUND FOR 1997

1. By 6 p.m. on 16 September 1996, 20 Members of the Agency had pledged contributions to the Technical Co-operation Fund for 1997 as shown in the table overleaf.
2. It is foreseen that the Conference will consider the matter of contributions pledged to the Technical Co-operation Fund in a plenary meeting at which the President will report on the contributions pledged by that time. Revisions of the present document will be issued as the session proceeds for the purpose of keeping the Conference informed of the pledges that Members are making.
