**SCALE OF ASSESSMENT OF MEMBERS' CONTRIBUTIONS FOR 1999**

1. The Director General submits herewith to the General Conference a draft resolution whereby the Conference may set, in accordance with Article XIV.D of the Statute, the scale of assessment of Members' contributions to the Agency's Regular Budget for 1999. The scale in Annex 1 of the attached draft resolution has been prepared in accordance with the principles and arrangements established by the General Conference<sup>1/</sup>. The scale, which is based on the Agency's membership as of 31 July 1998, includes two new States, the Republic of Moldova and Malta, which became Members on 24 September 1997 and 29 September 1997 respectively.
2. It will be noted that the following draft resolution also provides for approval by the General Conference of the base rate of assessment of each Member. This has been derived from the scale used by the United Nations to assess contributions from its Members to its Regular Budget for 1998 and adopted by the General Assembly in resolution 52/215 A on 22 December 1997. The 1998 scale of the United Nations is adjusted by applying a mathematical coefficient to compensate for differences in membership between the Agency and the United Nations.
3. The scale of assessment in Annex 1 of the attached draft resolution is based on the base rate, but takes into account that 95 Members (hereinafter referred to as "shielded" Members) will receive partial relief in respect of their assessments for the safeguards component of the Regular Budget (see Table 3 in the Appendix). The remaining 32 Members (hereinafter referred to as "unshielded" Members) will contribute on a proportionally increased basis in order to make up the balance of the safeguards expenses (see Table 4 in the Appendix).
4. The calculations that were made in order to establish both the individual base rates and the resulting scale of assessment are reproduced for the information of the Conference in the Appendix.

5. Member States are urged to inform the Director General by 1 January 1999 as to when their Regular Budget contributions will be paid to the Agency. This information is required in order to enable the Secretariat to prepare cash forecasts on the basis of which the Agency's programme will be implemented.

Draft resolution

SCALE OF ASSESSMENT OF MEMBERS' CONTRIBUTIONS FOR 1999

The General Conference,

Applying the principles it has established for the assessment of Members' contributions towards the Agency's Regular Budget<sup>2/</sup>,

1. Decides that the individual base rates and the resulting scale of assessment of Members' contributions to the Agency's Regular Budget for 1999 shall be as set forth in Annex 1 hereto; and
2. Determines, pursuant to Financial Regulation 5.09<sup>\*\*/</sup>, that in the event of a State becoming a Member of the Agency during the remainder of 1998 or in 1999 it shall be assessed as appropriate:
  - (a) for an advance or advances to the Working Capital Fund, in accordance with Financial Regulation 7.04<sup>\*\*/</sup> ; and
  - (b) for a contribution or contributions towards the Agency's Regular Budget, in accordance with the principles and arrangements the Conference has established for that purpose.

**A N N E X 2**

**Use of gross national product (GNP) figures instead of net national product (NNP) figures  
by the UN Committee on Contributions**

1. Resolution GC(39)/RES/11 refers, in operative paragraph 1 (c)(ii), to “Members having per capita net national products of less than one third of the average per capita net national product of the fifteen Members with the highest per capita net national products, the per capita net national products being identified by examination of the documents used by the Committee on Contributions of the General Assembly of the United Nations and the “shielded” list being reviewed and adjusted, if necessary, each time new documents on per capita net national products are made available by that Committee.”
2. Following a proposal submitted by the UN Committee on Contributions, the UN General Assembly decided on 22 December 1997, inter alia, to use GNP figures instead of NNP figures as one of the elements upon which the UN scale of assessment should be based (see General Assembly resolution 52/215 A). As a consequence of this decision, this year the Agency’s Secretariat was provided by UN Headquarters with only the GNP figures of Members. These figures have been used when drawing up the lists of “shielded” and “unshielded” Members, on the basis that the object and purpose of operative paragraph 1(c)(ii) of resolution GC(39)/RES/11 is to fix an equitable means of determining whether a State should be shielded or unshielded by reference to one of the elements used by the Committee on Contributions to establish an equitable UN scale of assessment.
3. If the General Conference adopts the present draft resolution and the scale annexed thereto, the Secretariat will take it that the General Conference has given its authority to use GNP figures in implementing resolution GC(39)/11 as long as GNP figures, rather than NNP figures, appear in the documents used by the Committee on Contributions.



## A P P E N D I X

### MEMBERS' CONTRIBUTIONS TO THE AGENCY'S REGULAR BUDGET FOR 1999

#### **The computation of the individual Regular Budget assessments**

1. As a first step in computing the individual Regular Budget assessments, the Agency's Regular Budget for 1999 is divided into a **safeguards component** and a **non-safeguards component**<sup>1</sup> as described below.

- (a) **The safeguards component** amounts to US\$ 12 045 000 plus AS 868 248 000 (US\$ 80 411 000 at an exchange rate of AS 12.70 to US\$ 1.00). The basis for the calculation of the safeguards component is shown in **Table 1**. As can be seen from the table, this component comprises all of programme L (Safeguards) and part of programme M (Security of Material) - namely; sub-programme M.1 (Information) and sub-programme M.2 (Protection of Nuclear Material); in addition, it includes sub-programme element O.1.07 (DDG Safeguards). An amount of US\$ 400 000 of income has been estimated to be recoverable under safeguards agreements with non-member States during 1999<sup>2</sup> and was subtracted from the total. Also, **Table 1** shows the distribution of the safeguards assessment between "shielded" and "unshielded" Members.
- (b) The **non-safeguards component** refers to all other programmes and amounts to US\$ 22 544 000 plus AS 1 417 701 000 (US\$ 134 174 000 at an exchange rate of AS 12.70 to US\$ 1.00).

Adding these two components, the total assessment proposed amounts to US\$ 34 589 000 plus AS 2 285 949 000, which, at an exchange rate of AS 12.70 to US\$ 1.00, amounts to US\$ 214 585 000<sup>3</sup>.

2. The next step is to derive a **base rate of assessment** for each Member of the Agency on the basis of the scale used by the United Nations to assess contributions from its Members to its budget for the year 1998<sup>4</sup>. As will be seen from **Table 2**, the United Nations percentage assessments for Members of the Agency that were also Members of the United Nations amount to 99.638 per cent and the United Nations rates of assessment for the other Members of the Agency amount to 1.216 per cent. The total figure of 100.854 per cent obtained by adding these two percentages is multiplied by a coefficient to establish the base rates of assessment for all Member States of the

Agency, which will give a total of exactly 100 per cent. In accordance with the principles established by the General Conference<sup>5</sup>, however, the coefficient is not applied in the case of the Member bearing the highest United Nations assessment or of the four Members bearing the lowest United Nations assessment. The coefficient is therefore calculated as follows:

3. It is now necessary to determine the respective shares of the safeguards component to be borne by the "**shielded**" Members. In accordance with the Revised Arrangements for the Assessment of Members' Contributions towards the Agency's Regular Budget [GC/RES/(39)11, sub-paragraph 1(c)(i)], "shielded" Members are not obliged to contribute to any increase in the safeguards budget beyond zero real growth. Accordingly, the amount of US\$ 4 017 000 which reflects a programme increase in the safeguards budget beyond zero real growth was deducted from the safeguards component for the purpose of calculating the shares of the "shielded" Members (see Table 1).

4. **Table 3** lists the 95 "**shielded**" Member States and the contributions to the safeguards component to be borne by each of them. It will be noted that in columns (2) and (3) of Table 3 the safeguards assessment amounts for each "shielded" Member were calculated on the basis of half of its base rate. In accordance with the transitional arrangements contained in sub-paragraph 1(d)(i) of General Conference resolution GC/(39)/RES/11, these amounts were compared with the contribution for 1995<sup>6</sup>. Four-fifths of the difference were added to the contribution for 1995 in order to obtain each "shielded" Member's final share of the safeguards assessment for 1999, which is shown in columns (4) and (5). The transitional arrangements apply only to the 86 Members listed in Table 2 in the Appendix to document GC(XXXVIII)/9.

5. The remaining safeguards expenses are borne by 32 "**unshielded**" Members, as shown in **Table 4**. Columns (3) and (4) show the amounts that will have to be paid by each "unshielded" Member as a result of proportionally increasing the base rate of assessment in such a way that the total contributions make up the balance of the safeguards assessment. Columns (6) and (7) show the final shares of each "unshielded" Member as a consequence of the transitional arrangements for "shielded" Members set forth in resolution GC(39)/RES/11.

6. Each **Member's share in the non-safeguards component** is calculated by applying its base rate of assessment to the total non-safeguards component.

7. For the convenience of Member States, **Table 5** shows each Member's share in the non-safeguards and the safeguards component, as well as the resulting **total assessment and percentage assessment**.
