REPORT ON CONTRIBUTIONS PLEDGED TO THE TECHNICAL CO-OPERATION FUND FOR 1999

1. By 6:30 p.m. on 23 September 1998, 45 Members of the Agency had pledged contributions to the Technical Co-operation Fund for 1999 as shown in the table in the annex.
