## REPORT ON CONTRIBUTIONS PLEDGED TO THE TECHNICAL CO-OPERATION FUND FOR 2000

1. By 7:30 p.m. on 28 September 1999, 29 Members of the Agency had pledged contributions to the Technical Co-operation Fund for 2000 as shown in the table in the annex.
2. It is foreseen that the Conference will consider the matter of contributions pledged to the Technical Co-operation Fund in a plenary meeting at which the President will report on the contributions pledged by that time. Revisions of the present document will be issued as the session proceeds for the purpose of keeping the Conference informed of the pledges that Members are making.
