REPORT ON CONTRIBUTIONS PLEDGED TO THE TECHNICAL CO-OPERATION FUND FOR 2001

1. By 7:30 p.m. on 20 September 2000, 44 Members of the Agency had pledged contributions to the Technical Co-operation Fund for 2001 as shown in the table in the annex.
2. It is foreseen that the Conference will consider the matter of contributions pledged to the Technical Co-operation Fund in a plenary meeting at which the President will report on the contributions pledged by that time.
