REPORT ON CONTRIBUTIONS PLEDGED TO THE TECHNICAL CO-OPERATION FUND FOR 2002

1. By 7:00 p.m. on 19 September 2001, 36 Members of the Agency had pledged contributions to the Technical Co-operation Fund for 2002 as shown in the table in the annex.
