# Text of Communication of 26 June 2003 received from the Minister of Foreign Affairs of the Republic of Armenia Concerning Restoration of Voting Rights

The text of a letter dated 26 June 2003 from the Minister of Foreign Affairs of the Republic of Armenia and addressed to the Director General is reproduced herewith for the attention of the General Conference.

OF THE REPUBLIC OF ARMENIA

Since the first years of independence, the Republic of Armenia has been committed to the purposes and objectives of the IAEA and its mission to promote the use of atomic energy for peaceful purposes. We have benefited substantially from the Agency's technical assistance programme, and from technical cooperation in regional and interregional projects. Nuclear power safety, as well as evaluation of seismic characteristics and radioactive waste management systems have been major areas of cooperation between Armenia and the IAEA.

Unfortunately, Armenia has accumulated arrears to the IAEA that have resulted in our losing voting privileges and therefore diminishing active engagement in the decision-making process. The Government of Armenia is anxious to participate fully in the work of the Agency, to settle its outstanding contributions and restore its voting rights.

The Government of Armenia undertakes to pay the total arrears to the Regular Budget and Assessed Programme Costs, as well as budget and programme costs assessments from 2003 onward, in accordance with the payment plans enclosed in the annex. Armenia also requests that the IAEA Board of Governors, in case it adopts a new decision, considers the possibility for a 10-year payment plan for the outstanding regular budget contributions as well.

Having made this commitment, the Government of Armenia asks that the General Conference consider restoring Armenia's voting rights with immediate effect.
