Report on Contributions Pledged to the Technical Cooperation Fund for 2006

1. By 7:15 p.m. on 27 September 2005, 31 Members of the Agency had pledged contributions to the Technical Cooperation Fund (TCF) for 2006 as shown in the table in the annex.
