# Report on Contributions to the Technical Cooperation Fund for 2007

1. By 8:00 p.m. on 19 September 2006, 35 Members of the Agency had pledged contributions to the Technical Cooperation Fund (TCF) for 2007 as shown in the table in the annex.
2. It is foreseen that the Conference will consider the matter of contributions pledged to the TCF in a plenary meeting at which the President will report on the contributions pledged by that time. Revisions of the present document will be issued as the session proceeds for the purpose of keeping the Conference informed of the pledges that Members are making.
