# Amendment to Article VI of the Statute

*Report by the Director General*

1. On 1 October 1999, in resolution GC(43)/RES/19 the General Conference, at its 43<sup>rd</sup> regular session, approved an amendment to Article VI of the Agency's Statute and urged all Member States to accept this amendment as soon as possible. Further to the Conference's request in the same resolution, the Secretariat submitted a report to the 45<sup>th</sup> regular session of the General Conference on the progress made towards the entry into force of this amendment (GC(45)/INF/7).

2. In response to further requests by the General Conference, the Director General submitted further reports, on the progress made towards entry into force of this amendment, to the 47<sup>th</sup> and 49<sup>th</sup> regular sessions of the General Conference (GC(47)/INF/5 and GC(49)/3). At its 49<sup>th</sup> regular session, by decision GC(49)/DEC/12, the General Conference again "encourage[d] all Member States which ha[d] not yet done so to accept the amendment as soon as possible in accordance with their respective constitutional processes". The same decision took note of the report and requested the Director General to submit to the General Conference at its 50<sup>th</sup> regular session a report on the progress made towards the entry into force of the amendment.

3. The purpose of this document is to provide an updated report to Member States on the progress made.

## **Progress Made towards Entry into Force**

4. One of the requirements for entry into force of the amendment is that, in accordance with Article XVIII.C(ii) of the Statute, two-thirds of all Member States of the Agency have to accept the amendment. Since the report to the last regular session of the General Conference, only one Member State has accepted the amendment, thereby bringing the number of Member States that have accepted the amendment to 43.

5. Attached as an Annex is a list of those States whose acceptance of the amendment has been notified by the depositary Government to the Agency as of the date of this document.
