# Report on Contributions Pledged to the Technical Cooperation Fund for 2009

1. By 5:30 p.m. on 26 September 2008, 7 Members of the Agency had pledged contributions to the Technical Cooperation Fund (TCF) for 2009 as shown in the table in the annex.
