# Statement of Financial Contributions to the Agency as at 11 September 2009

*Report by the Director General*

1. Statements of financial contributions to the Agency reflecting the situation as at the end of 2008 are contained in the Agency's Accounts for 2008<sup>1</sup>. For the convenience of the General Conference, the contributions statements have been updated to reflect the situation as at 11 September 2009 and are reproduced in the annex as follows:

2. Article XIX.A of the Statute reads as follows:

“A member of the Agency which is in arrears in the payment of its financial contributions to the Agency shall have no vote in the Agency if the amount of its arrears equals or exceeds the amount of the contributions due from it for the preceding two years. The General Conference may, nevertheless, permit such a member to vote if it is satisfied that the failure to pay is due to conditions beyond the control of the member.”

3. For the information of the Conference, Table 5 indicates those Members to which Article XIX.A of the Statute applied on 11 September 2009. For each of these Members the table shows inter alia, the minimum amount payable in order to avoid the application of this article.
