a/ Cambodia has fulfilled its payment plan instalment for 2013 however restoration of voting rights has to be requested in order to regain its right to vote.

b/ Payment plan agreement concluded with the Agency in September 2007 and started in 2008. However, the Dominican Republic has not made the necessary payments since 2008, as required by the plan. The minimum amounts required as per the payment plan agreement are €898 720 plus US \$43 885.

c/ Payment plan agreement was concluded with the Agency in 2009. Gabon has not made the necessary payments in 2013 as required by the plan. The minimum amounts required as per the payment plan are €11 953 US \$7494.
