Statement of Financial Contributions to the Agency

Report by the Director General

1. Status of financial contributions to the Agency reflecting the situation as at the end of 2013 is reported in *The Agency's Financial Statements for 2013*² and the status of financial contributions in the current year is reported in the Notes by the Secretariat *2014/Note23* and *2014/Note59*. For the convenience of the General Conference, the status of contributions statements have been updated to reflect the situation as at 19 September 2014 and are reproduced in the Annex as follows:

RB Attachment 1	Status of contributions to the Regular Budget;
WCF Attachment 2	Status of advances to the Working Capital Fund;
TCF Attachment 3	Status of voluntary contributions to the Technical Cooperation Fund;
APC Attachment 4	Status of payments of Assessed Programme Costs;
NPC Attachment 5	Status of payments of National Participation Costs.

2. Article XIX.A of the Statute reads as follows:

“A member of the Agency which is in arrears in the payment of its financial contributions to the Agency shall have no vote in the Agency if the amount of its arrears equals or exceeds the amount of the contributions due from it for the preceding two years. The General Conference may, nevertheless, permit such a member to vote if it is satisfied that the failure to pay is due to conditions beyond the control of the member.”

For the information of the Conference, VR Attachment 6 (Member States with no voting rights) indicates those Members to which Article XIX.A of the Statute applied on 19 September 2014. For each of these Members the table shows, inter alia, the minimum amount payable in order to avoid the application of this article.
