## Sixty-fifth regular session

# Provisional agenda

1. In accordance with Rule 2 of the Rules of Procedure of the General Conference<sup>1</sup>, the Director General hereby notifies all Members of the Agency that the sixty-fifth regular session of the General Conference will open in the M Building of the Vienna International Centre (VIC) on Monday, 20 September 2021, at 10.00 a.m.
2. During the weekend preceding the opening of the Conference's session (Saturday, 18 September and Sunday, 19 September 2021), facilities will be made available for group meetings. Member States are strongly urged to avail themselves of those facilities, with a view to achieving early agreement on organizational matters, by participating in pre-session group meetings and the associated group decision-making. Meeting rooms may be reserved through the Secretariat's Conference Services Section (tel.no.: +43 1 2600 21312).
3. Pursuant to Rule 11 of the Conference's Rules of Procedure, the Director General has drawn up the attached provisional agenda for the session in consultation with the Board of Governors. In the annotation to each item a suggestion is made, for consideration by the General Committee, as to whether it should first be discussed in plenary or in a committee.
4. Should the Director General receive by 21 August 2021 any request under Rule 13 for inclusion of a supplementary item in the agenda, such an item will, unless Rule 21 applies, be placed on a list which will be circulated not later than 31 August 2021.

## Annotations

**1. Election of officers and appointment of the General Committee<sup>2</sup> *Plenary***

Under Rule 34 of the Rules of Procedure, the General Conference will be called upon to elect a President. In accordance with Rules 34 and 40, the Conference will also be called upon to elect eight Vice-Presidents, a Chairman of the Committee of the Whole and five additional members on the proposal of the President.

**2. Applications for membership of the Agency *Plenary***

The General Conference will have before it one or more recommendations by the Board of Governors regarding applications for membership of the Agency.

**3. Message from the Secretary-General of the United Nations *Plenary***

It is expected that a message from the Secretary-General of the United Nations will be delivered.

**4. Statement by the Director General *Plenary***

The Director General is expected to make a statement to the Conference.

**5. Arrangements for the Conference *Plenary***

**(a) Adoption of the agenda and allocation of items for initial discussion *General Committee***

The General Committee is required to report to the Conference under Rule 42(a) on the provisional agenda set forth in the present document and on any supplementary or additional items (Rules 13 and 15). The Conference will then approve the agenda (Rule 14) and allocate the items for initial discussion.

**(b) Closing date of the session and opening date of the next session *General Committee***

The Conference is required, under Rule 8, to set the closing date of the session and, under Rule 1, to set the opening date of the sixty-sixth (2022) regular session after considering recommendations made by the General Committee.

**6. Contributions to the Technical Cooperation Fund for 2022 *Plenary***

Member States will be urged to pledge contributions to the Technical Cooperation Fund for 2022 and attention will be drawn to the fact that such pledges of contributions can be made during the session.

**7. General debate and Annual Report for 2020 *Plenary***

Under Article V.E.4 of the Statute, the Conference is required to consider the Agency's *Annual Report for 2020*, which the Board has approved (document GC(65)/XX).

## **8. The IAEA and the COVID-19 Pandemic**

*Plenary*

This item is included in the provisional agenda pursuant to resolution GC(64)/RES/3. The Conference will have before it three reports by the Director General:

- GC(65)/INF/XX on IAEA Support to Member State Efforts in Addressing the COVID-19 Pandemic;
- GC(65)/INF/XX on IAEA Safeguards Implementation during the COVID-19 Pandemic; and
- GC(65)/INF/XX on the Operation, Safety and Security of Nuclear and Radiation Facilities and Activities during the COVID-19 Pandemic.

## **9. Election of Members to the Board of Governors**

*Plenary*

The Conference will be called upon to elect 11 Members to the Board<sup>3</sup>. Under Rule 83, the President will indicate to the Conference those elective places on the Board which must be filled so as to ensure that after the end of the session the Board will be constituted in accordance with Article VI.A of the Statute. Designations made in accordance with Article VI.A.1 of the Statute for membership on the Board in 2021–2022 are set out in document GC(65)/XX.

## **10. The Agency's Financial Statements for 2020**

*Committee of the Whole*

In accordance with Rule 12(i), *The Agency's Financial Statements for 2020*, together with the External Auditor's report thereon and the report of the Board, are being communicated to the Conference in document GC(65)/XX.

## **11. The Agency's Programme and Budget for 2022-2023**

*Committee of the Whole*

Under Article V.E.5 of the Statute, the Conference is called upon to approve *The Agency's Programme and Budget for 2022-2023*, which the Board, pursuant to Article XIV.A, is submitting to it in document GC(65)/XX.

## **12. Appointment of the External Auditor**

*Plenary*

The tenure of the Agency's External Auditor will end with the completion of the audit of the Agency's financial statements for the financial year 2021. It will therefore be necessary, in accordance with General Conference decision GC(61)/DEC/14, to appoint an External Auditor to audit the Agency's financial statements for the financial years 2022 to 2027. A recommendation by the Board of Governors to this effect may be before the Conference.

## **13. Amendment to Article XIV.A of the Statute**

*Committee of the Whole*

By resolution GC(43)/RES/8 the General Conference approved an amendment to Article XIV.A of the Agency's Statute, permitting biennial budgeting. This item is included in the provisional agenda pursuant to decision GC(64)/DEC/10. As requested in that decision, a report on the progress made towards the entry into force of this amendment is contained in document GC(65)/XX.

**14. Scale of assessment of Member States' contributions towards the Regular Budget for 2022** *Committee of the Whole*

Pursuant to Article XIV.D of the Statute, a proposed scale of assessment of Member States' contributions towards the Regular Budget for 2022 will be submitted to the Conference.

**15. Nuclear and radiation safety** *Committee of the Whole*

Pursuant to resolution GC(64)/RES/9, it is expected that the General Conference will have before it reports by the Director General on a number of issues, including:

- developments in items under resolution GC(64)/RES/9; and
- the *Nuclear Safety Review 2021* (document GC(65)/INF/XX).

**16. Nuclear security** *Committee of the Whole*

This item is included in the provisional agenda pursuant to resolution GC(64)/RES/10. It is expected that the General Conference will have before it the *Nuclear Security Report 2021* (document GC(65)/XX) and the *Nuclear Security Plan 2022-2025* (document GC(65)/XX).

**17. Strengthening of the Agency's technical cooperation activities** *Committee of the Whole*

This item is included in the provisional agenda pursuant to resolution GC(64)/RES/11 to enable the Director General to report on the implementation of the resolution as requested in its operative paragraph A.6.1.

**18. Strengthening the Agency's activities related to nuclear science, technology and applications** *Committee of the Whole*

This item is included in the provisional agenda pursuant to resolutions GC(63)/RES/10 and GC(64)/RES/12. It is expected that the General Conference will have before it reports on a number of issues, including:

- developments in items under resolutions GC(63)/RES/10 and GC(64)/RES/12; and
- the *Nuclear Technology Review 2021* (document GC(65)/INF/2).

**19. Strengthening the effectiveness and improving the efficiency of Agency safeguards** *Committee of the Whole*

This item is included in the provisional agenda pursuant to resolution GC(64)/RES/13, adopted by the General Conference last year. The Director General will report to the Conference on the implementation of the resolution as requested in its operative paragraph 41.

**20. Implementation of the NPT safeguards agreement between the Agency and the Democratic People's Republic of Korea** *Plenary*

This item is included in the provisional agenda pursuant to operative paragraph 15 of resolution GC(64)/RES/14, in which the General Conference decided last year to remain seized of this matter and to include this item in the agenda for its sixty-fifth (2021) regular session.

**21. Application of IAEA safeguards in the Middle East** *Plenary*

This item is included in the provisional agenda pursuant to resolution GC(64)/RES/15 adopted by the General Conference last year. The Director General will report to the Conference on the implementation of the resolution as requested in its operative paragraph 13.

**22. Amendment of Article VI of the Statute**

*Committee of the Whole*

By resolution GC(43)/RES/19 the General Conference approved an amendment to Article VI of the Agency's Statute. This item is included in the provisional agenda pursuant to the decision of the Conference contained in decision GC(63)/DEC/13. As requested in that decision, a report on the progress made towards the entry into force of this amendment is contained in document GC(65)/XX.

**23. Personnel**

*Committee of the Whole*

**(a) Staffing of the Agency's Secretariat**

This sub-item is included in the provisional agenda to enable the Director General to report on the implementation of resolution GC(63)/RES/14.A as requested in its operative paragraph 11.

**(b) Women in the Secretariat**

This sub-item is included in the provisional agenda to enable the Director General to report on the implementation of resolution GC(63)/RES/14.B as requested in its operative paragraph 10.

**24. Elections to the Agency's Staff Pension Committee**

*Committee of the Whole*

The Conference may be called upon to elect representatives from Member States to serve on the Agency's Staff Pension Committee.

**25. Examination of delegates' credentials**

*General Committee*

Under Rule 28 of the Rules of Procedure the General Committee, meeting as a credentials committee, will examine the credentials of all delegates and report thereon to the Conference.

**26. Report on contributions pledged to the Technical Cooperation Fund for 2022**

*Plenary*

It is expected that pledges of contributions to the Technical Cooperation Fund for 2022 will be obtained during the Conference and that the President will communicate a report thereon to the Conference.
