Explanatory Note on the agenda item entitled: "Restoration of sovereign equality in the IAEA"

As a follow up to the deliberations of the 65th General Conference and the following sessions of the Board of Governors under the same agenda item, the issue of "Restoration of sovereign equality in the IAEA" requires further progress.

The Agency is based on the principle of the sovereign equality of all its members; and ensures to all of them the rights and benefits resulting from the membership (Article IV.C). Thus, the activities of the Agency shall be carried out with due observance of the sovereign rights of States (Article III.D).

The membership of the Board of Governors requires representation in the areas (Article VI.A). But taking into account that the Statute does not assign members to specific areas as defined in its Article VI.A.1. and there are no established criteria for getting into any of them, some full-fledged Member States for at least 30 years are outside of the areas (so called regional groups) and have no further perspective to join them.

It is also a concern that the sovereign equality of the IAEA members is an issue within the areas, i.e. regional groups. The lack of procedural and agreed regulations inside the areas is a reason for growing absence of consensus and accord on nomination processes within the areas and violation of the fundamental principle of equality in the Agency. We all cooperate on equal ground with due respect of all parties in accordance with universal and indivisible core values of democracy, equality and transparency. No Member State has the right for a veto on geographical belonging and representation of an area as such.

An amendment to Article VI of the Agency's Statute of 1999 is an important threshold in restoration of the sovereign equality of all IAEA members, which is yet to come into force. There is a need for introducing a fair international mechanism that will complement this amendment and boost its early entry into force.

The inclusion of an item entitled "Restoration of sovereign equality in the IAEA" in the agenda of the 66th regular session of the General Conference will contribute to finding a solution on restoration of equality in a democratic way for the benefit of the health of our "common house" – the IAEA.
