# Provisional agenda

- 1. In accordance with Rule 2 of the Rules of Procedure of the General Conference, the Director General hereby notifies all Members of the Agency that the sixty-seventh regular session of the General Conference will open in the M Building of the Vienna International Centre (VIC) on Monday, 25 September 2023, at 10.00 a.m.
- 2. During the weekend preceding the opening of the Conference's session (Saturday, 23 September and Sunday, 24 September 2023), facilities will be made available for group meetings. Member States are strongly urged to avail themselves of those facilities, with a view to achieving early agreement on organizational matters, by participating in pre-session group meetings and the associated group decision-making. Meeting rooms may be reserved through the Secretariat's Conference Services Section (+43 1 2600 21312).
- 3. Pursuant to Rule 11 of the Conference's Rules of Procedure, the Director General has drawn up the attached provisional agenda for the session in consultation with the Board of Governors. In the annotation to each item a suggestion is made, for consideration by the General Committee, as to whether it should first be discussed in plenary or in a committee.
- 4. Should the Director General receive by 28 August 2023 any request under Rule 13 for inclusion of a supplementary item in the agenda, such an item will, unless Rule 21 applies, be placed on a list which will be circulated not later than 5 September 2023.

### 1. Election of officers and appointment of the General Committee<sup>1</sup>

**Plenary** 

Under Rule 34 of the Rules of Procedure, the General Conference will be called upon to elect a President. In accordance with Rules 34 and 40, the Conference will also be called upon to elect eight Vice-Presidents, a Chairman of the Committee of the Whole and five additional members on the proposal of the President.

#### 2. Applications for membership of the Agency

Plenary

The General Conference may have before it one or more recommendations by the Board of Governors regarding applications for membership of the Agency.

#### 3. Message from the Secretary-General of the United Nations

Plenary

It is expected that a message from the Secretary-General of the United Nations will be delivered.

#### 4. Statement by the Director General

**Plenary** 

The Director General is expected to make a statement to the Conference.

### 5. Arrangements for the Conference

# (a) Adoption of the agenda and allocation of items for initial discussion

General Committee

The General Committee is required to report to the Conference under Rule 42(a) on the provisional agenda set forth in the present document and on any supplementary or additional items (Rules 13 and 15). The Conference will then approve the agenda (Rule 14) and allocate the items for initial discussion.

# (b) Closing date of the session and opening date of the next session

General Committee

The Conference is required, under Rule 8, to set the closing date of the session and, under Rule 1, to set the opening date of the sixty-eighth (2024) regular session after considering recommendations made by the General Committee.

#### 6. Approval of the Appointment of the Director General

**Plenary** 

Under Article VII.A of the Statute, the Director General is appointed by the Board of Governors with the approval of the General Conference for a term of four years. The term of the Director General ends on 2 December 2023. On 6 March 2023, the Board decided on an appointment to the post of Director General, who is to serve from 3 December 2023 to 2 December 2027. In document GC(67)/8 the Board is seeking the Conference's approval of this appointment.

### 7. Contributions to the Technical Cooperation Fund for 2024

Plenary

Member States will be urged to pledge contributions to the Technical Cooperation Fund for 2024 and attention will be drawn to the fact that such pledges of contributions can be made during the session.

It is hoped that this measure will help area groups to reach agreement on their nominees for membership of the General Committee **before Monday morning** so that the work of the Conference can proceed without delay.

#### 8. General debate and Annual Report for 2022

Plenary

Under Article V.E.4 of the Statute, the Conference is required to consider the Agency's *Annual Report* for 2022, which the Board has approved (document GC(67)/2).

#### 9. Election of Members to the Board of Governors

Plenary

The Conference will be called upon to elect 11 Members to the Board<sup>2</sup>. Under Rule 83, the President will indicate to the Conference those elective places on the Board which must be filled so as to ensure that after the end of the session the Board will be constituted in accordance with Article VI.A of the Statute. Designations made in accordance with Article VI.A.1 of the Statute for membership on the Board in 2023-2024 are set out in document GC(67)/3.

#### 10. The Agency's Financial Statements for 2022

Committee of the Whole

In accordance with Rule 12(i), *The Agency's Financial Statements for 2022*, together with the External Auditor's report thereon and the report of the Board, are being communicated to the Conference in document GC(67)/4.

#### 11. The Agency's Programme and Budget 2024–2025

Committee of the Whole

Under Article V.E.5 of the Statute, the Conference is called upon to approve *The Agency's Programme* and *Budget 2024–2025*, which the Board, pursuant to Article XIV.A, is submitting to it in document GC(67)/5.

#### 12. Amendment to Article XIV.A of the Statute

Committee of the Whole

By resolution GC(43)/RES/8 the General Conference approved an amendment to Article XIV.A of the Agency's Statute, permitting biennial budgeting. This item is included in the provisional agenda pursuant to decision GC(66)/DEC/10. As requested in that decision, a report on the progress made towards the entry into force of this amendment is contained in document GC(67)/6.

# 13. Scale of assessment of Member States' contributions towards the Regular Budget for 2024

Pursuant to Article XIV.D of the Statute, a proposed scale of assessment of Member States' contributions towards the Regular Budget for 2024 will be submitted to the Conference.
