Amendment to Article VI of the Statute

Report by the Director General

- 1. On 1 October 1999, in resolution GC(43)/RES/19, the General Conference, at its 43rd regular session, approved an amendment to Article VI of the Agency's Statute and urged all Member States of the Agency to accept this amendment as soon as possible. Further to the Conference's request in the same resolution, the Secretariat submitted a report to the 45th regular session of the General Conference on the progress made towards the entry into force of this amendment (GC(45)/INF/7).
- 2. In response to further requests by the General Conference, the Director General submitted further reports on the progress made towards entry into force of this amendment (see GC(47)/INF/5, GC(49)/3, GC(50)/7, GC(51)/7, GC(53)/10, GC(55)/9, GC(57)/6, GC(59)/10, GC(61)/9, GC(63)/11, GC(65)/12, and GC(67)/9. At its 67th regular session, by decision GC(67)/DEC/10, the General Conference, as before, "encourage[d] all Member States which ha[d] not done so to accept the amendment as soon as possible in accordance with their respective constitutional processes". The same decision took note of the report and requested the Director General to submit to the General Conference at its 69th regular session a report on the progress made towards the entry into force of this amendment.
- 3. The purpose of this document is to provide an updated report to Member States on the progress made.

Promotion and Outreach Activities

4. The Director General has actively encouraged those Member States that have not yet accepted the amendment to do so, including during bilateral meetings and other engagements with representatives of Member States. As part of these efforts, the Agency took part in a side event organized by Member States during the 68th regular session of the General Conference to promote the amendment. In addition, the Agency has developed outreach material to support awareness-raising activities conducted by the Office of Legal Affairs to Member States, including legislative assistance.

Progress Made towards Entry into Force

- 5. In accordance with Article XVIII.C(ii) of the Statute, two-thirds of all Member States of the Agency (i.e. 120 States as of the date of this document) have to accept the amendment in order for it to enter into force. Since the report to the 67th regular session of the General Conference, the Agency has been informed by the depositary Government that four Member States have accepted the amendment. Consequently, the number of Member States that have accepted the amendment is sixty-eight.
- 6. Attached as an Annex is a list of those States whose acceptance of the amendment has been notified by the depositary Government to the Agency as of 12 June 2025.
