Introduction

1. This document contains financial and statistical data that supplement the Technical Cooperation (TC) Report for 2024. The information is grouped under three headings: Resources and Contributions, Actuals and Implementation Summaries¹, and Non-financial Indicators.

A. Resources and Contributions

The financial tables and graphs in this section show the resources received from various sources for TC activities.

B. Actuals and Implementation Summaries

The financial tables and graphs in this section show actuals (monetary outlays) and implementation against the programme for the year 2024 (budget as at year end).

C. Non-financial Indicators

TC programme delivery can be expressed in both financial and non-financial terms. Non-financial delivery (outputs) can be expressed numerically in terms of, for example, experts deployed, or training courses conducted. The tables and graphs in this section provide figures for the outputs delivered through the TC programme.

2. Unless otherwise specified, all figures in this document are expressed in Euro, which has been the functional currency for the TC programme since January 2011. For comparison purposes, figures in the document that have already been presented to the Board in US dollars are presented in this document in Euro, using the United Nations rate of exchange (UNROE). For all pre-2011 figures, the UNROE for 31 December 2010 of €0.761 is used. Due to rounding, amounts in tables may not add up exactly to the totals shown.

3. The countries are grouped by technical cooperation (TC) programme region in most of the tables. A list of Member States in each TC region is provided in Annex 1 of this supplement.

4. The information contained in this Supplement is available in electronic form upon request. It is also available to registered users on GovAtom.

¹ Terminology has changed with the implementation of AIPS/Oracle. Encumbrances are the equivalent of obligations, and actuals are the equivalent of disbursements.

A. Resources and Contributions

Table A.1: Available resources, 2015-2024

5. This table shows resources by source of funding for the past decade, based on the year in which the funds became available. Technical Cooperation Fund (TCF) ‘other income’ includes national participation costs (NPCs) and assessed programme cost (APC) arrears received and miscellaneous income. Other resources (extrabudgetary funds from Member States, organizations and in-kind contributions) are shown separately.

Table A.2: Technical Cooperation Fund, 2015-2024

6. This table shows the ten year trend in the development of the target for contributions to the TCF, amounts pledged and payments against these pledges. The rate of attainment is obtained by dividing the payments made to the TC Fund by the TCF target for a given year.

Table A.3: Member State contributions pledged and paid to the Technical Cooperation Fund, 2024

7. This table reports on pledges and payments to the 2024 TCF, against the 2024 target of €96 million. The table is sorted according to the percentage of their portion of the rate of attainment paid by each country. Of the 177² States that were Members of the IAEA in 2024, 111 paid their share in full (or exceeded it), 16 made partial payments, and 50 made no payment in 2024.

Table A.4: Assessed programme cost arrears and national participation costs

8. Part A of this table reports on APC arrears as of 31 December 2024, presented in US dollars. Part B of the table presents amounts invoiced for 2024 under the NPC mechanism, together with amounts received as of 31 December 2024. Figures in part B are presented in Euros (the amounts reported in 2011 in US dollars were converted to Euros).

Table A.5: Status of extrabudgetary funds, 2024

9. This table shows the status of extrabudgetary donor contributions to the TC programme. Funds Available represent the unobligated balance at the end of the year prior to the reporting year. Interest allotted is the interest income for the year prior to the reporting period. Allotment of New Funds represents the allocation of extrabudgetary funds towards TC Projects during the reporting period. Deallotments represent the transfer outside of TC in the reporting period in line with Donor instruction. The Total Funds in the reporting period exclude Actuals and Encumbrances of the reporting period.

10. Part B of the table shows contributions from countries to their own TC projects, commonly referred to as ‘government cost-sharing’.

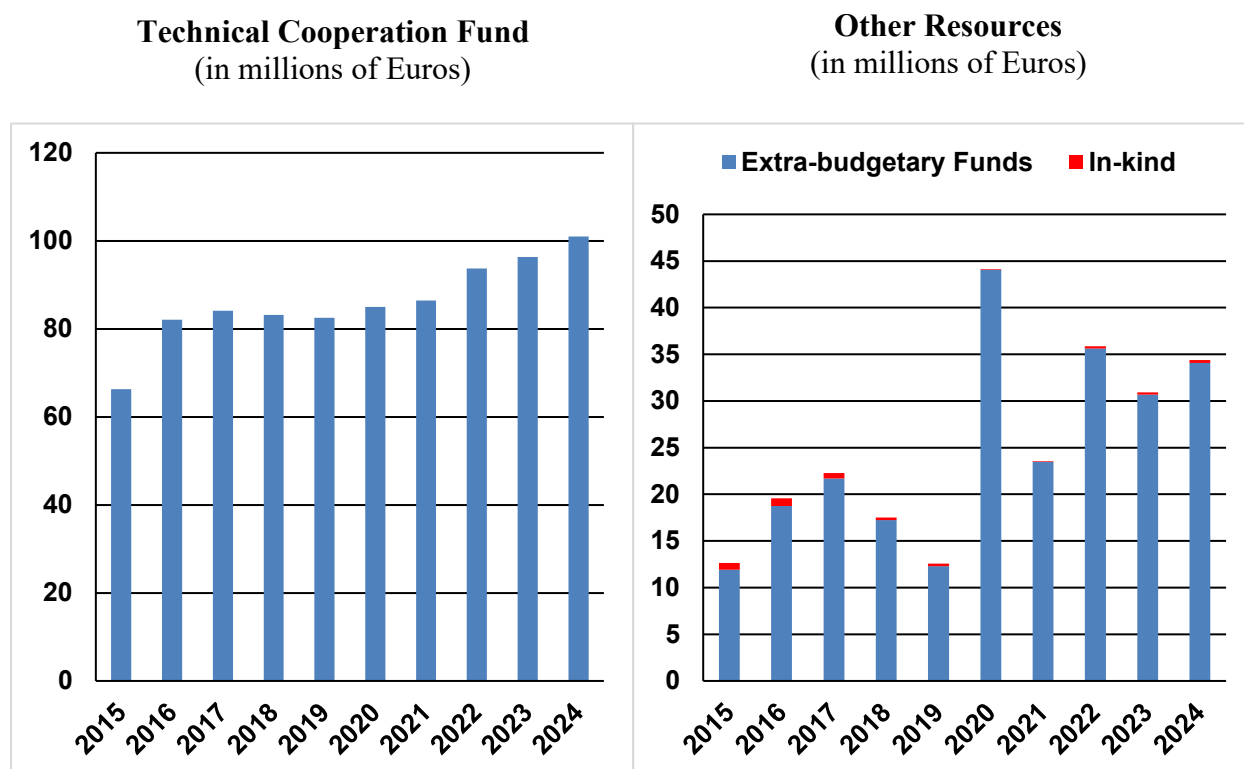
11. This table shows in-kind support provided by 58 Member States. For in-kind support, resources and delivery are equal.

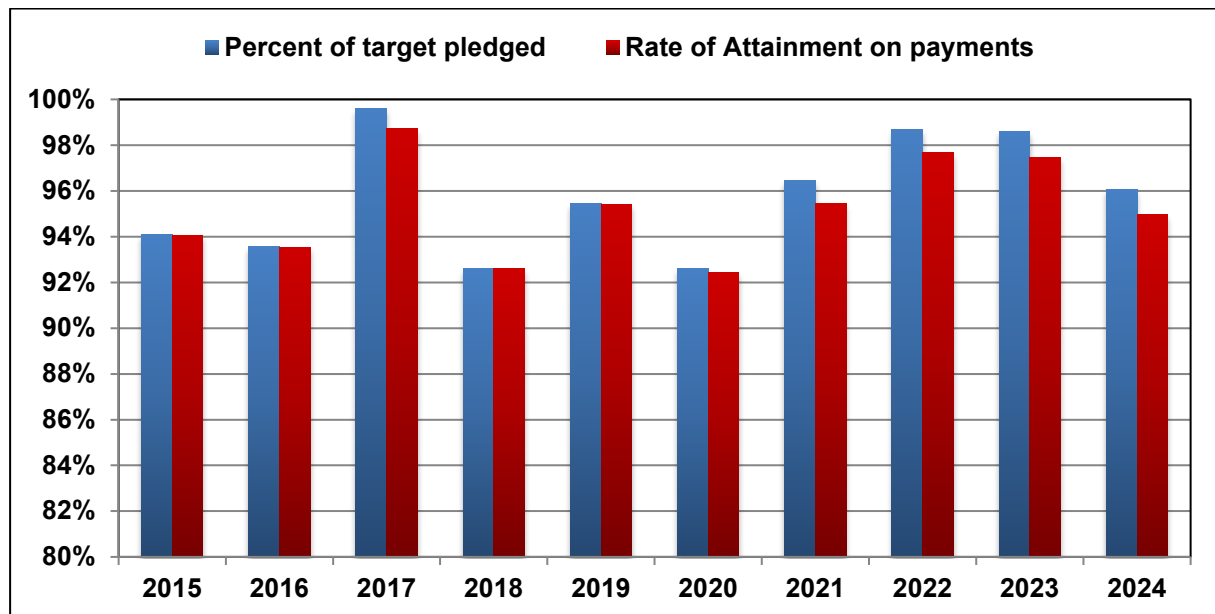

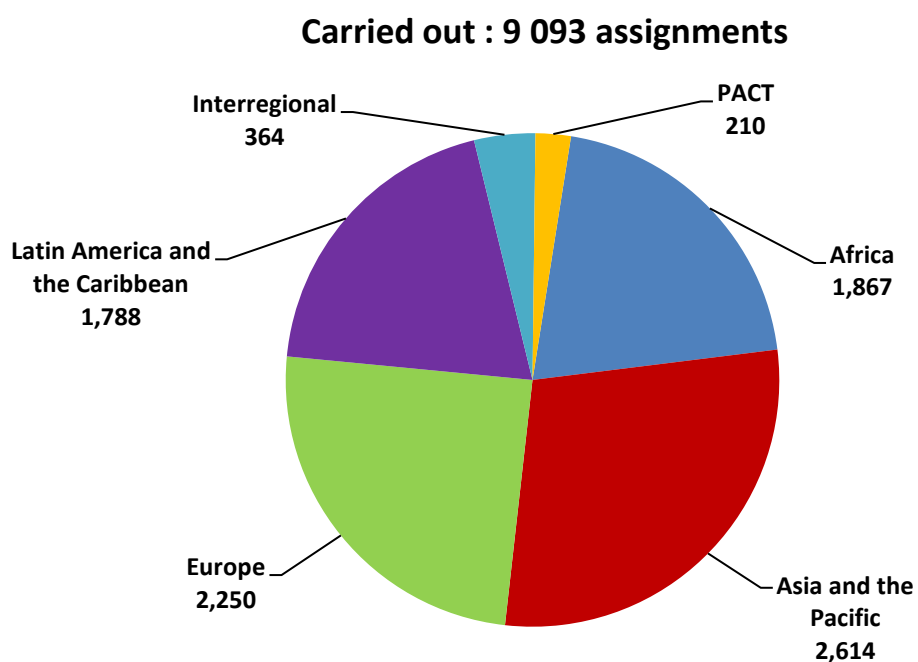

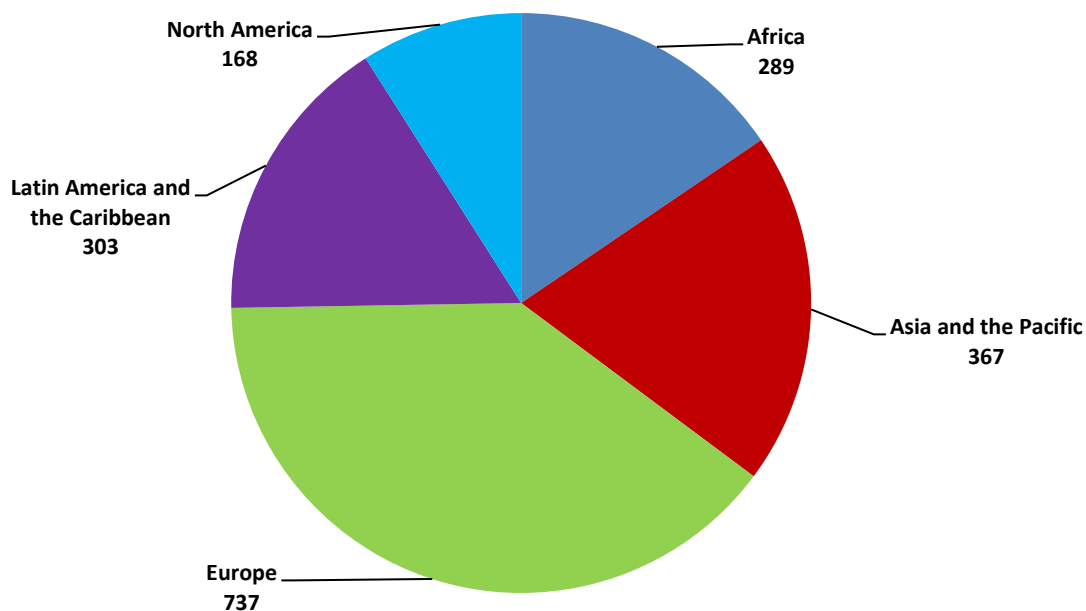
