

SUMMARY OF MEETINGS

held on Monday, 20 September 2021

Plenary 1st meeting

The Conference, under agenda **item 1** of the provisional agenda, "Election of officers and appointment of the General Committee", elected by acclamation HE Mr Sadiq Marafi, Ambassador and Resident Representative of Kuwait to the IAEA, as President of the General Conference at its sixty-fifth regular session.

In line with a proposal by the President, the Conference elected: the delegates of Denmark, Ghana, Iraq, Paraguay, Poland, Thailand, United States of America and Viet Nam as Vice-Presidents of the Conference; the delegates of Angola, Belgium, Bulgaria, Malta and Panama as additional members of the General Committee, and Mr Alexandre Bilodeau, Deputy Resident Representative of Canada to the IAEA, as Chairperson of the Committee of the Whole.

Under agenda **item 5** of the provisional agenda, "Arrangements for the Conference", the Conference approved arrangements contained in the annex of document GC(65)/17 so that the Conference could pursue its work in the current circumstances of the COVID-19 pandemic.

Under agenda **item 2** of the provisional agenda, "Applications for membership of the Agency", the Conference approved by acclamation the application for membership of the Agency submitted by the Federation of Saint Christopher (Saint Kitts) and Nevis. Under agenda **item 3** of the provisional agenda, a message from the Secretary-General of the United Nations, Mr António Guterres, was delivered to the General Conference by Ms Ghada Fathi Waly, Director-General of the United Nations Office at Vienna. Under agenda **item 4** of the provisional agenda, Mr Rafael Mariano Grossi, Director General of the IAEA, gave a statement to the Conference.

Under agenda **item 6** of the provisional agenda, "Contributions to the Technical Cooperation Fund for 2022", the President made a statement regarding the early pledging and payment of contributions to the Technical Cooperation Fund for 2022, which greatly helps the Secretariat in planning the Agency's technical cooperation programme.

The Conference took up agenda **item 7** of the provisional agenda, "General debate and Annual Report for 2020", and statements were made by the delegates of Honduras, Colombia, the Islamic Republic of Iran, Slovenia (on behalf of the European Union), Saudi Arabia, Russian Federation, China, France and United States of America.





General Committee

The General Committee recommended to the Conference that:

1st meeting

- the agenda for the current session of the General Conference consist of all the items on the provisional agenda set forth in document GC(65)/1, Add.1, Add.2 and Add.3;,
- the allocation of items for initial discussion listed in documents GC(65)/1, Add.1, Add.2 and Add.3 be taken up for discussion as indicated in these documents;
- the order of items be as set out in documents GC(65)/1, Add.1, Add.2 and Add.3; and
- Friday, 24 September 2021 be set as the closing date of this session; and the General Conference start its next regular session on Monday, 19 September 2022.

Meeting as Credentials Committee, the General Committee took up the item on "Examination of delegates' credentials" and recommended to the Plenary to approve the draft resolution contained in paragraph 4 of the first Report of the Committee contained in document GC(65)/29.

Plenary 2nd meeting

Under **item 5**, "Arrangements for the Conference", the conference accepted the General Committee's recommendations that the agenda for the current session consist of all the items on the provisional agenda set forth in document GC(65)/1 and of all the supplementary items set forth in documents GC(65)/1/Add.1, Add.2 and Add 3 and that they be taken up for discussion in the order as set out in these documents.

The Conference accepted the General Committee's recommendation to close this session on Friday, 24 September 2021.

The Conference accepted the General Committee's recommendation to start its next regular session on Monday, 19 September 2022.

The Conference took up **item 25** of the agenda, "Examination of delegates' credentials", and considered the first General Committee's report contained in document GC(65)/29. The Conference adopted the draft resolution contained in paragraph 4 of the first Report of the General Committee's report contained in document GC(65)/29.

The Conference resumed agenda **item 7** of the provisional agenda, "General debate and Annual Report for 2020". Statements were made by Turkey, Sweden, Brazil, Belgium, Denmark, Slovakia, Niger, Namibia, Senegal, Malta, Finland, Ukraine, Lithuania, Egypt, Ghana, Portugal, Poland and Montenegro.
