COMMUNICATION RECEIVED FROM CHINA CONCERNING ITS POLICIES REGARDING THE MANAGEMENT OF PLUTONIUM

- 1. The Secretariat has received two letters, dated 28 September 2001 and 3 September 2002 respectively, from the Permanent Mission of China to the IAEA in the enclosures of which the Government of China, in keeping with its commitment under the Guidelines for the Management of Plutonium (contained in INFCIRC/549 of 16 March 1998 and hereinafter referred to as the "Guidelines") and in accordance with Annexes B and C of the Guidelines, has made available information on its national holdings of civil unirradiated plutonium as at 31 December 1999, 31 December 2000, and 31 December 2001.
- 2. In the light of the request expressed by China in its note verbale of 1 December 1997 concerning its policies regarding the management of plutonium (INFCIRC/549 of 16 March 1998) the texts of the enclosures of the letters of 28 September 2001 and 3 September 2002 are attached for the information of all Member States.
