## Communication Received from the United Kingdom of Great Britain and Northern Ireland Concerning its Policies Regarding the Management of Plutonium

### Statements on the Management of Plutonium and of High Enriched Uranium

1. The Secretariat has received a note verbale dated 6 June 2011 from the Permanent Mission of the United Kingdom of Great Britain and Northern Ireland to the IAEA in the enclosures of which the Government, in keeping with its commitment under the Guidelines for the Management of Plutonium (contained in INFCIRC/549<sup>1</sup> of 16 March 1998 and hereinafter referred to as the “Guidelines”) and in accordance with Annexes B and C of the Guidelines, has made available annual figures for its holdings of civil unirradiated plutonium and the estimated amounts of plutonium contained in spent civil reactor fuel as of 31 December 2010.
2. The Government of the United Kingdom has also made available a statement of its annual figures for holdings of civil high enriched uranium and of civil depleted, natural and low enriched uranium in the civil nuclear fuel cycle as of 31 December 2010.
3. In light of the requests expressed by the Government of the United Kingdom in its note verbale of 1 December 1997 concerning its policies regarding the management of plutonium (INFCIRC/549 of 16 March 1998) and in its note verbale of 6 June 2011, the note verbale and the enclosures thereto are attached for the information of all Member States.

The Permanent Mission of the United Kingdom of Great Britain and Northern Ireland to the United Nations and the International Organisations in Vienna presents its compliments to the Director-General of the International Atomic Energy Agency and has the honour to refer to its Note Verbale No 001/97 of 1 December 1997, enclosing Guidelines specifying the policies that the Government of the United Kingdom of Great Britain and Northern Ireland has decided to apply to the management of plutonium.

In addition, that communication recognised the sensitivity of high enriched uranium and the need to manage stocks of such material with the same sense of responsibility as the plutonium covered by the Guidelines.

In keeping with the United Kingdom's commitment under the Guidelines on Plutonium to make available annually, information on its national holdings of civil unirradiated plutonium and of plutonium contained in spent civil reactor fuel, the Government of the United Kingdom encloses with this Note, the figures for the United Kingdom's holdings as at 31 December 2010. These are set out in accordance with Annexes B and C of the Guidelines. The Government of the United Kingdom also encloses with this Note a statement of the United Kingdom's national holdings of civil high enriched uranium and civil depleted, natural and low enriched uranium (DNLEU) in the civil nuclear fuel cycle as at 31 December 2010.

The Government of the United Kingdom of Great Britain and Northern Ireland requests the Director-General of the International Atomic Energy Agency to circulate this Note and its attachment to all Member States for their information.

The Permanent Mission of the United Kingdom of Great Britain and Northern Ireland avails itself of this opportunity to renew to the Director-General of the International Atomic Energy Agency the assurances of its highest consideration.
