#### SUPPLY AGREEMENT

# CONTRACT FOR THE TRANSFER OF ENRICHED URANIUM FOR A RESEARCH REACTOR

#### AMENDMENT NUMBER ONE

WHEREAS the International Atomic Energy Agency (hereinafter called the "Agency"), the Government of the Democratic Republic of the Congo (hereinafter called the "Congo") and the United States Atomic Energy Commission (hereinafter called the "Commission"), acting on behalf of the Government of the United States of America, on 27 June 1962 signed a contract for the transfer of enriched uranium (hereinafter called the "Supply Agreement") [2] for the TRICO research reactor (hereinafter called the "reactor");

WHEREAS the Agency and the Congo on 27 September 1966 signed an agreement for additional assistance by the Agency to the Congo (hereinafter called the "Project Extension Agreement")[3] for upgrading the reactor and improving its usefulness for peaceful purposes; and

WHEREAS, in connection with the Project Extension Agreement, the Board of Governors of the Agency on 16 June 1967 approved the supply of the additional enriched uranium requested by the Congo for the reactor;

NOW, THEREFORE, the Agency, the Commission and the Congo hereby agree as follows:

#### ARTICLE I

## Amendment of the Supply Agreement

Section 1. Section 1(a) of the Supply Agreement is revised to read as follows:

"(a) Up to 1400 grams of uranium enriched to approximately 20 % by weight in the isotope uranium-235 (hereinafter called the "fuel material"), the precise quantities to be determined pursuant to Section 3(b), contained in up to seven supplementary fuel elements for a 250-kilowatt TRIGA Mark II research reactor (hereinafter called the "TRICO reactor")."

Section 2. All other provisions of the Supply Agreement remain unchanged.

#### ARTICLE II

#### Entry into Force

Section 3. This Amendment shall enter into force upon signature by the Director General of the Agency and by the authorized representatives of the Commission and the Congo.
